Inclement Weather Policy

The Wolfeboro Library is open for business unless there is a government declared state of emergency or unless you are advised otherwise by your supervisor. There may be times when we delay opening, and on rare occasions, we may have to close. Use common sense and your best judgement when travelling to work in inclement weather.

In the event that the Library's facilities are closed by the Library or the government, scheduled employees will be paid for the day. If the Library's facilities are open and you are delayed getting to work or cannot get to work at all because of inclement weather, the absence will be charged to leave time or unpaid time off. You should always use your own judgement about your safety in getting to work.

When severe weather develops or is anticipated to develop during the day and a decision is made by the Library to close before the regularly scheduled close of business, you will be compensated as if you had worked to the end of your regularly scheduled hours for that day. If you elect to leave prior to the time the Library closes, you may use leave time in an amount equal to the number of hours between the time you left and the time Library closed or you may choose to go unpaid.

Inclement Weather Policy

Wolfeboro Library staff members should monitor the weather via television, internet, radio and cell phone what weather conditions are before venturing on the roads. Staff safety is a paramount concern to the Wolfeboro Library.

The Library Director shall close the Library:

- During a state of emergency at the direction of a governing official
- When the facility is not habitable.

The Library Director will close, delay or open the Library later when:

- Wolfeboro Town Hall is closed for inclement weather.
- Advised by the Town Manager, Board Chair or other official that a delay or closure for the day would be safer.



Staff who are scheduled to work on a day that becomes an inclement weather day will be paid normal wages even if sent home early. If the Library is open and a staff member is unable to come due to the weather they may choose to take leave or unpaid time off.
