



# **OVERVIEW**

The Lakes Region continues to grow and evolve. As our economy and world change, so does the work we are engaged in. The Lakes Region Planning Commission (LRPC) is an organization established according to state law to provide area communities and the region with the capacity to respond to and shape the pressures of change in a purposeful way. With a service area covering over 1,200 square miles in Belknap, Carroll, Grafton and Merrimack Counties, the LRPC provides a wide range of planning services to member municipalities. We address regional issues which are beyond the capability of individual towns to address, yet affect all communities within the region. Our services include technical assistance, geographic information systems, transportation planning, land use, environmental planning, hazard planning, and economic development. Local, state, and federal resources primarily fund the LRPC. We also maintain a regular dialogue with state agencies as a resource for the entire Lakes Region. Our overall goal is to provide support, knowledge, and leadership to the governments, businesses, and citizens of the Lakes Region.



The Spotlight section is designed to highlight the many services and activities conducted by the LRPC over the past year. Key program areas are emphasized, including: natural resources, land use, transportation, housing, economic development, utilities, public facilities and natural hazards. Each town also receives a customized description of local and regional activities for use in its Annual Report.

#### LAND USE

In addition to ongoing daily requests for technical assistance related to mapping, zoning, subdivisions, etc., LRPC is often asked to work on specific planning projects. A few examples are as follows:



Completed Master Plan assistance to the town of Andover and initiated assistance to the town of Center Harbor as part of a major update of its Master Plan.

Assisted the town of Effingham with a proposed scope of work for an update of their Master Plan.

Provided Circuit Rider assistance to the town of Northfield planning board and the zoning board of adjustment.

Continued to work with the town of Ossipee on the development of their Capital Improvement Program.



Assisted the town of Sanbornton with the update of several maps for their Master Plan.

Prepared the 2010 Development Activity in the Lakes Region report and distributed to survey participants.

Received funding from the Pardoe Foundation to conduct Smart Growth Assessments (SGA) for the cities of Laconia and Franklin. These reports provide insights to local communities regarding the consistency of their ordinances and regulations with livability goals.

Responded to daily requests for land use, transportation, environmental, and other information and guidance. Helped organize and co-host three public Municipal Law Lectures, in cooperation with the NH Local Government Center, where included the following topics:

- Constitutional Issues in Land Use Regulations
- The Five Variance Criteria in the 21<sup>st</sup> Century
- What Do You Do When They Stop Building? Vested Rights, Modified Approvals, Violations and Revocation

#### FY-11 LAND USE ASSISTANCE:

Responded to requests for technical assistance while identifying areas that may need special emphasis. Additional Master Plan assistance to the towns of Ashland, Center Harbor, Effingham, and Sanbornton is underway. Circuit Rider assistance to the town of Northfield will also continue. The town of New Hampton recently requested

# ECONOMIC DEVELOPMENT



Applied for and secured \$400,000 in Brownfields funding from the U.S. Environmental Protection Agency (EPA) to help local communities identify vacant and underused sites for redevelopment and productive reuse.

Completed the Lakes Region Comprehensive Economic Development Strategy (CEDS), A Plan for Sustainable Progress, and submitted it to the U.S. Economic Development Administration (EDA) for acceptance. The plan was officially accepted in May 2010.

Coordinated an Economics Day for Leadership Lakes Region and co-presented the Lakes Region Comprehensive Economic Development Strategy (CEDS) to attendees.

Planned and facilitated four Lakes Region CEDS committee meetings throughout the year, and initiated another application to the EDA to help the region explore the possibility of creating an economic development district.

As a member of the Lakes Region Facility Commission, LRPC played a key role in securing assistance from EPA to conduct a preliminary reuse assessment of the former Lakes Region Facility property in Laconia.

#### **FY-11 ECONOMIC DEVELOPMENT ASSISTANCE:**

Continue to coordinate with area economic development groups including Belknap County Economic Council (BCEDC), Grafton County Economic Development Council (GCEDC), Franklin Business and Industrial Development Corporation (FBDIC), and the Wentworth Economic Development Council (WEDCO) in pursuit of workforce development and wealth creation opportunities for the region. Submitted an application to EDA to determine the viability of creating an economic development district for the Lakes Region, and to update the CEDS.

## TRANSPORTATION

Convened ten meetings of the Transportation Technical Advisory Committee (TAC).

Submitted a prioritized list of regional Transportation Enhancement (TE) projects to the NH Department of Transportation (NHDOT) for funding: two projects totaling

\$597,320 were approved — safety enhancements in Bristol and a bicycle/ Pedestrian bridge over the Winnipesaukee River in Northfield.

Evaluated Safe Routes to School (SRTS) applications.

Provided regional input at several meetings of the Governor's Advisory Committee on Intermodal Transportation (GACIT).



Released the NH Route 28 Corridor Safety Study, a biregional effort with the CNHRPC and NHDOT.

Completed 150 week-long traffic counts around the region, including Laconia.

Completed Road Surface Management System (RSMA) inventories in Meredith and Moultonborough.

## **FY-11 TRANSPORTATION ASSISTANCE:**

Continue to convene meetings of the TAC. Will explore the development of the Lakes Region Scenic Tour Byways.

Efforts will continue on a re-write of a Regional Bicycle and Pedestrian Plan.

Assistance will be provided to approximately eight communities on the Highway Safety Improvement Plan top 100 list.

Master Plan assistance will be provided to three communities.

Assist North Country Council and Central NH Regional Planning Commission with area Regional Coordination Councils.

#### FY-11 NATURAL HAZARDS ASSISTANCE:

In FY11, the LRPC will continue to work with NH HSEM to identify communities that need updates to the hazard mitigation plans. We have already started updates for the town of Gilmanton and the city of Laconia. Updates are being planned for Tamworth, Ashland, and Gilford.

#### UTILITY AND PUBLIC SERVICE

Completed a Phase I Lakes Region Broadband Study to determine the extent and capacity of existing broadband services in the region.

Modified and improved Community Facility maps for the regional towns and posted them to LRPC's website.

Facilitated the Energy Alliance meeting held in Campton at the White Mountain National Forest (WMNF) headquarters complex. WMNF staff, New Hampshire Co-op and Jordan Institute representatives provided an overview and discussion on the energy efficiencies and systems at the complex and conducted a tour of the facility.

Planned and facilitated a third Lakes Region Alliance meeting. The Alliance is a consortium of local energy committees brought together to share ideas and activity.

The Energy Technical Assistance and Planning (ETAP) for NH communities was officially launched at the conference. In attendance were other RPC representatives and state energy conference members of local energy committees from the Lakes Region and other Regions of NH. LRPC is the main point of contact for the ETAP program.

#### FY-11 UTILITY AND PUBLIC SERVICE

**ASSISTANCE:** In FY 11, LRPC will continue to offer assistance under the ETAP program, which is designed to help NH communities track and understand energy consumption in municipal buildings.


We will also remain engaged in the NH Broadband Mapping Program, which will include additional outreach to help complete a comprehensive inventory of broadband access points.

LRPC also expects to re-engage the Comprehensive Economic Development Strategy (CEDS) New Economy committee to guide the development of a broadband redevelopment plan.

#### FY 10 BUDGET

The pie charts below depict the distribution of actual revenues and expenditures from July 1, 2009 through June 30, 2010. Federal and state contracts represent the largest share of LRPC's funding, which continues to reflect the LRPC's capacity to enhance local appropriations by 1:5 ratio.





#### NATURAL RESOURCES (Conservation, Preservation, etc.)

Presented water resources ordinances for the Regional Environmental Planning Program (REPP) at a statewide planning conference.



Received an award from the NH Department of Environmental Services (NHDES) for success in helping the towns of Belmont, Northfield and Tilton protect their drinking water quality.

Received funding from the NHDES to work with the Green Mountain Aquifer Conservation Group (GMCG) and several municipalities to protect groundwater in the Ossipee aquifer.

With assistance from U.S. Senator Gregg, received \$100,000 from the National Oceanic and Atmospheric Administration Prepared the 2010 Development Activity in the Lakes Region (NOAA) to expand planning, monitoring, and communication report and distributed to survey participants. efforts for the Lake Winnipesaukee Watershed Management Plan (LWWMP). **FY-11 HOUSING ASSISTANCE:** 

Continued to represent the region at the Lakes Region Household Hazardous Product Facility to explore the ways and means the facility may encourage other communities to participate.

Received support through the NHDES and the federal American Recovery and Revitalization Act (ARRA) to continue to work on the Pemigewasset Watershed Co-occurrence Model.



The 2010 HHW collections were the largest collection ever in terms of volume were received and safely disposed.

#### FY-11 NATURAL RESOURCES ASSISTANCE:

The LWWMP will have a new web site, which will include the novel approach of using the internet as a water quality plan for the Paugus, Saunders, Meredith bays subwatershed of Lake Winnipesaukee.

With project partners, we submitted an application to DES to focus on the Center Harbor Bay subwatershed in FY 11 and 12, which will include the towns of Meredith, Center Harbor and Moultonborough.

Continue to organize and coordinate two annual Household Hazardous Waste (HHW) collections, involving 24 member communities, at eight locations around the region.

# HOUSING



Participated in the housing needs assessment methods meeting hosted by the NH Housing Finance Authority (NHHFA).

Prepared and distributed the 2010 Development Trends Report to communities and the news media.

Drafted a process to conduct a Housing Audit to help communities determine if their planning regulations and laws are in compliance with the Workforce Housing law.

Participated in workforce housing forums with the Work Here, Live Here CEDS Committee, and the Eastern Lakes Region Housing Coalition.

The recent completion of the LRPC Regional Housing Needs Assessment topped our overall housing efforts in the past year. In FY 11, we expect to continue to assist communities interested in knowing more about the workforce housing law. We also intend to continue to inform our overall economic development strategy with strategies and programs developed through highly successful organizations such as the Laconia Area Land Trust and the Eastern Lakes Region Housing Coalition.

# NATURAL HAZARDS

With funding from the Federal Emergency Management Agency (FEMA) and support through the NH Department of Homeland Security and Emergency Management (HSEM), LRPC continued to assist local



communities with the preparation and updates of hazard mitigation plans (HMP).

The town of Bridgewater received assistance for projects identified in their HMP.

The town of Bristol's HMP received approval from FEMA.

An update of Alexandria's HMP was completed.

Working with local emergency staff, final Local Emergency Operation Plans were completed for the towns of Meredith, Moultonborough and New Hampton.
