Call to Order - Meeting called to order by Jennifer Schulz at 6:48 pm.

Roll Call - President Jennifer Schulz, Vice President Richard McGlew, Treasurer Gwendolyn Newton, trustees Karen Wyns and Eric Shotwell present. Secretary Jake Dudek absent, excused. Director April Stevenson and Assistant Director Amy Rosen in attendance.

<u>Approval of the Agenda</u> - Motion to approve the agenda as presented made by Richard McGlew and seconded by Eric Shotwell. Motion carried. (4 yes votes)

  - Motion to invest \$225,000 in a Genisys CD for a term of 7 months made by Richard McGlew and seconded by Karen Wyns. Motion carried. (4 yes votes)
  - Motion made by Gwendolyn Newton and seconded by Eric Shotwell to approve the updated EFT/ACH Approved Vendors List with the following changes:
    - "Change Normal Amount Range" to "Maximum Amount"
    - Add: "In the case of an overage, a Board Trustee, granted signature authority, may approve an exception. If the EFT/ACH will continue to be more monies than listed in the 'approved vendor list', the board will review the increase in the subsequent board meeting." Motion carried. (4 yes votes)
- Strategic Planning Committee -
  - The Committee has hired Library Strategies as consultants to assist with our Strategic Plan. The Library Director has already sent the Data Analysis wish list to the consultants. Regular meetings have been scheduled.
- Policy Committee -
  - The Staff Policy Committee has begun meeting.
