


State of New Hampshire Division of Parks and Recreation 2024 Library Pass Program



Getting outdoors is the perfect way to connect with nature, family, and friends! NH State Parks are here to help by offering NH municipal libraries the opportunity to participate in the Library Pass Program. By purchasing a Library Pass, your patrons will have the ability to get outdoors and make memories when they reserve the pass with you. Once they have reserved the pass from the library, all they need to do is choose the NH State Park they wish to visit with their family. We strongly recommend they make a reservation prior to arriving as that is the only way to guarantee access into the park. See below for more information.

Cost:	\$105.00 per pass
Dates Valid:	January 1, 2024, through December 31, 2024
Valid for:	Pass is valid for 2 adults and up to 4 dependents to gain access at no additional charge to all our day- use parks.
Restrictions:	The pass is NOT valid at the Cannon Mountain Aerial Tramway, the Flume Gorge, Hampton Beach State Park – South Beach or Wallis Sands State Park. The pass cannot be used for camping and is not valid at the metered parking areas. The pass is ONLY valid for the date listed on the pass. There is no cash value on the pass and the pass cannot be exchanged for a different date.
How it works:	Once payment is received, the Division of Parks and Recreation will set up a daily "tour" for each pass purchased in the name of the Library. Once the "tour" is booked for a specific date, no other tours for the Library can be booked for the same date on that pass by Library staff.
How to obtain pass:	Once the Division of Parks and Recreation receives payment for the pass, a link with log-in information will be sent to the library to access the pass online. This link must ONLY be accessed by library staff. When a patron wishes to use the pass, they will contact the library and provide the desired date. The library staff will log in and ensure that the pass is available for that date requested. The library will then print the admission ticket for the patron to pick up from the Library prior to their Park visit.
Reservations:	IMPORTANT: Patrons need to know that this pass DOES NOT guarantee access to any park. Advanced day-use reservations are the only way to guarantee access to a park.
	When requesting a reservation, the patron will be charged a \$1 non-refundable reservation fee charged by the software company. To avoid being charged the admission fee, the patron will indicate that they have a library pass when making the reservation. The system will remove the admission fees, however the patron will be responsible for the \$1 reservation fee. Entrance into park:	When the patron visits the park, the admission ticket will be verified at the tollbooth. The toll attendant will issue a receipt and enter the Library pass number into the computer.
Replacement plan:	With the pass now on-line, no passes will need to be returned to the library, therefore, lost passes are no longer a concern.
