## 1. Welcome & Introductions / Call to Order

## 2. Items of Information

- a. <u>Vulnerable Road User Safety Assessment Draft</u>
  - i. S. Chamberlin announces final draft of New Hampshire Vulnerable Road User Safety Assessment is being finalized by NHDOT. Offers to provide copies to TAC. Discusses what the assessment covers.
  - ii. Breaks down some of the statistics found in the assessment. Question from TAC is this about the roads being vulnerable or the people? S. Chamberlin explains the assessment is for vulnerable people safety (users of the road).
  - iii. Discusses and reviews charts from the assessment and reviews work that RPCs and TAC will be responsible for.
  - iv. Questions asked about complete streets program and NHDOT standards for that.
  - v. Possible discussion about more complete streets at future TAC in the spring.
  - vi. Discussions about access to crash data and other related information for crash analysis is an ongoing discussion at the state level.
  - vii. S. Chamberlin tells TAC that RPC has been looking into bike/ped counters and other info about gathering more data on this info.
  - viii. NHDOT rep, Lucy, states this assessment is a federal mandate for states to produce.
- b. <u>HB412</u>

- i. S. Chamberlin provides background on HB412 bill that created a committee to investigate and report on alternative road taxes for alternative fueled vehicles.
- ii. S. Chamberlin says current tax rate has lost 50 percent of purchasing power do to various factors
- iii. S. Chamberlin states HB412 Committee looked into mileage-based annual fees.
- iv. S. Chamberlin states Federal and NH Fuel Tax rate has not increased since 1993 and 2014 respectively.
- v. S. Chamberlin elaborates on questions about HB412 by the TAC members.
- vi. One TAC member mentioned vehicle weight being used as a possible factor for fees.
- c. <u>Transition to DPW</u>
  - i. S. Chamberlin begins discussion on the benefits of transitioning from separate departments to a DPW.
  - ii. SC gives examples from Alton that were provided by Scott Kimmond Alton DPW Director.
  - iii. SC opens floor to open discussion on topic.
  - iv. Plymouth states happy with their organization.
  - v. Gilford discusses current organization and past experiences at other municipalities. Gilford and Plymouth bring up that departments can usually sign up for mutual aide. Gilford states it feels like everything is more of a team and organization under the umbrella of a DPW. Another attendee states a similar viewpoint of being a team as a DPW.
  - vi. Primex study came up on positive work environments based off organization member thinks it was Merrimack were the study was done.
  - vii. Plymouth states with their structure only some departments are union while most are not even without DPW, departments work very well together and provide mutual assistance with one another.
  - viii. Gilmanton speaks about their current transition from elected road agent to a DPW. Currently cross training individuals.
  - ix. Discussions on having separate village commissions (like water and sewer) rather than departments or DPW.
  - x. Gilford speaks about how water and sewer under DPW would be preferred to coincide maintenance with roadwork.
  - xi. Members speak on budgeting with departments and DPWs.
  - xii. Gilford speaks about getting infrastructure assessments done by LRPC and to use those as tools to increase budgets.
  - xiii. Laconia asked about what other communities were tax capped Laconia was the only one that identified as one. Bristol school district is believed to be tax capped that's large part of the taxes.
  - xiv. SC discusses the expected transition time (~one year) to DPW and make sure roles and responsibilities are clear.
  - xv. Members state that it is hard to find elected positions/road agents that live in town (requirement). Hard to find individuals interested and/or qualified.
  - xvi. S. Kimmond provides information on current LTAP and UNH T2 assistance for Gilmanton on their hiring process for DPW director. LTAP provides this assistance to municipalities by request.
