

Wilton Public and Gregg Free Library  
Trustee Board Public Meeting Minutes  
January 19, 2024

The meeting was called to order at 8:05 a.m. at the Wilton Public and Gregg Free Library. Attending were Library Director Jane Nikander and trustees Nikki Andrews, Ron Brown, Peter Howd, Alison Meltzer, Lynne Stone, and Mary Ellen Brookes and alternate trustees Felice Fullam and Arlene Laurenitis.

Trustee Molly Shanklin and alternate trustee Bill Langille were absent. Sue Putnam, treasurer of the Friends of the Library, attended as an invited guest.

Alison began by thanking Mrs. Putnam for her work and the contributions of the other Friends. Felice then explained their role in the work of the library.
