OLD BUSINESS

Furnace:

Irving came and did an estimate for the furnace with the liner at 20,020.00 and without the liner for 14,080.00, and the tank outside for 3,918.00. The existing furnace seems to be in good working order. There is a tank that sits on the piping which Is an external expansion tank. Eileen will call Stafford to see if that external expansion tank needs to be replaced. Shela and Eileen will work on creating a maintenance log for the furnace working backwards. Eileen will call Irving and schedule a cleaning of the furnace system. If the cost if more than \$400 approval will be needed.

Shela makes a motion to approve up to \$400 for the furnace cleaning. Mary seconded, all in favor.

Eileen is still waiting to hear about whether we need to ask for permission before applying for grants.

The Friends of the Library are in fundraising mode. There is a possible sledding event from the parks and rec during February vacation.
