

#### **Bulky Waste Disposal**



Beginning Wednesday, September 2, 2020, and on the 1st Wednesday of each month following, Casella Waste will collect your bulky items curbside. Please note this is for Town of Belmont Residential Customers ONLY; service is not available to commercial property owners. Piles of debris, trash, yard waste or a single item too large for one person to collect WILL NOT BE ACCEPTED. A request for pickup must be made in advance by calling Town Hall at 267-8300, Extension 118 or 124 only. You will be asked to list the items you want picked up, you will be advised what the cost is, and you will need to drop off a check made payable to the Town of Belmont prior to the collection day. ## **Town Clerk's Corner**

It's finally official! We are excited to see our residents again on Monday, April 5<sup>th</sup> as Town Hall reopens to the public! Quarter one water and sewer bills are due on April 8<sup>th</sup>. The first quarter utility bills cover the months of December, January, and February. As a reminder unpaid balances regarding taxes, water, and/or sewer from 2020 will have a lien placed on the property later this spring if they are not paid in full. Payments can be made either by mail, drop box, in person (after we open), or on the town's website. 
Did your family recently expand with a new K-9 member? Every year between January 1<sup>st</sup> and April 30<sup>th</sup> we will need to license those pups! All we need is the rabies information as well as basic information for the owner. Homes that have an owner 65+ will get one dog at \$2. Dogs that have been altered are \$6.50, non-altered are \$9.00, and homes that have 5+ dogs qualify for the group rate of \$20. Dog licenses that were issued in 2020 are due to expire on April 30<sup>th</sup>. It is very important that those adorable furry family members get their annual bling for their collars. If your dog has recently been to the vet, please bring the updated rabies to get their file up to date.

## **New Police Officer**


We want to welcome Officer Cobis to the Belmont Police Department. Officer Cobis was sworn in as our newest member of the department and has already begun his

## **Parking Ban**

NO PARKING -The parking ban will be in affect starting November 15th until April 15th. Overnight on street parking will not be allowed during this time. Objects in the RIGHT OF WAY such as basketball hoops and such should also be removed.



### NOTICE OF LOAD RESTRICTIONS

The Town of Belmont will be posting its roads to a maximum weight limit of 6 Tons, starting Monday, March 8<sup>th</sup>, 2021, during the spring thaw, per RSA 231:190-191 and continuing until roads once again become solid.

Each spring the Town of Belmont posts all Town roads to a maximum weight limit of 6 tons during the spring thaw per RSA 231:190-191. Local roads are especially vulnerable to damage in the spring due to the water freeze-thaw cycle. Imposing temporary weight limits can help to protect the roads during this time. Contractors, con-

struction companies, parcel services, fuel services and solid waste haulers are asked to observe the posting by staying off soft road shoulders and reducing load weights.

Special permission may be given for "practical difficulty or unnecessary hardship" depending upon weather conditions and time of day. However, Prior approval is required and a bond for the cost of restoring the road may also be required for any exceptions.

The following vehicles are exempt: firefighting equipment, winter maintenance equipment that is owned, leased or rented by state or any political subdivision of the state, and farm equipment. Violators may be charged with a "violation" under RSA 231:191,VI resulting in a fine of up to \$1,000 along with restitution for damages and civil liability. Call the Public Works Department at 603-528-2677 with any questions.



Please take note of the frost heaves signs we have placed throughout the town. Frost heaves can pop up anytime this time of year. We try to warn motorist of the ones we feel are the worst but cannot mark them all.

## **Code Enforcement Office**



Spring has sprung, and it just might be time to replace those old inefficient windows that have fogged up inside the panes, or perhaps parts of the window frame are starting to show their age (rot), or they just don't open properly like they used to.

Here are some things you should look for before you purchase windows. Ask your contractor or installer what kind of energy efficient features the windows come with.


- Should you purchase vinyl or wood?
- Should they be double-pane, triple-pane or low-E glass?
- What does it mean to have gas-filled panes?
- What is the U-Factor of the windows? (U-Factor generally refers to the energy efficiency of the complete window assembly. The lower the U-Factor, the better the window. Codes in our area require a U-Factor of 0.30 or lower.)
- Be sure to shop around and compare prices.

As always, before starting any building project, please give us a call and we will be happy to help you determine if a permit is required.

## **Conservation Commission**

The Conservation Commission (BCC) wants to thank the voters of Belmont for soundly rejecting Warrant Article #25 that meant to reduce the portion of the Land Use Change Tax (LUCT) that is levied as land comes out of Current Use (CU) assessment from 100% to 50% to be deposited in the Conservation Fund. The final vote to reject the article was 323-195 showing that Belmont voters have a clear understanding about the importance of land conservation. The New Hampshire Association of Conservation Commissions (NHACC) congratulated the Town for rejecting the proposed article in its March newsletter.

The NHACC newsletter also spot-lights the Amherst Conservation Commission that is proposing a \$6 Million bond open space warrant article later this year to purchase conservation land to protect natural areas and water resources. The bond was proposed in response to increasing development pressure in town and an overwhelming desire by town residents to protect open space and water resources. Fortunately, Belmont is being pro-active and purchasing valuable conservation properties for future generations now and, hopefully, won't need to take such drastic actions to save wild spaces that Amherst is looking at.





The rationale behind using the LUCT for conservation purchases is that the BCC uses the 1/10 of the value of land as it comes out of CU – a temporary conservation practice – to invest in the permanent protection of conservation lands. The Fund has also been used to undertake larger repairs on the BCC managed properties.

The BCC has used this money in the Fund for the purchase of significantly valuable land, whether it be exemplary wildlife habitat, outstanding passive recreation or a unique property. The practice has been that special emphasis be placed protecting lands bordering the Tioga River. Another consideration used is to expand contiguous areas to make large forested blocks for protection of wildlife.

All properties managed by the BCC are open to the public for passive recreation – walking, hunting and fishing. The Andrew Sanborn Farm property, with its existing roads, is enjoyed by horseback riders and mountain bikers.

In the last 26 years, the BCC has spent \$1,015,974 on 575 acres of protected property paid for by monies from the LUCT into the Conservation Fund. That adds up to \$1,768 per acre and \$39,075 per year.

It is vitally important to remember that the Town is forever – the BCC is preserving properties for 50 – 100 years and more into the future.


