Bulky Waste Disposal



Beginning Wednesday, September 2, 2020, and on the 1st Wednesday of each month following, Casella Waste will collect your bulky items curbside. Please note this is for Town of Belmont Residential

Customers ONLY; service is not available to commercial property owners. Piles of debris, trash, yard waste or a single item too large for one person to collect WILL NOT BE ACCEPTED. A request for pickup must be made in advance by calling Town Hall at 267-8300, Extension 118 or 124 only. You will be asked to list the items you want picked up, you will be advised what the cost is, and you will need to drop off a check made payable to the Town of Belmont prior to the collection day. Please visit the Town's website at www.belmontnh.org for the full details on the new program and a price.

Town Clerk's Corner

2021 is flying by, and it is hard to believe it is already time for the first issue property tax bills to go out! By May 15th the first tax bill will be mailed, so make sure you keep an eye out for them. The first issue tax bill is an estimated tax bill, it is half of what was paid in the previous year. The bills will be due in July. When it comes to making your payment, you may accomplish that in several ways. The website for the town www.belmontnh.org is a very popular spot for payments. We have a drop box in the front door, or come on into Town Hall to complete the payment. If you choose to mail in your payment, please send it to PO Box 310, Belmont, NH 03220. We ask for those interested in paying cash to please come inside the building to pay in person. As a reminder please wear a mask, social distance, and if you feel sick please wait to come in the building.

In addition to the tax bills going out, water, sewer, and/or taxes that were due in 2020 that are not paid in full will be part of the 2021 liens. Certified notices will go out this month to the property owners that are in the position to have a lien recorded at the Registry of Deeds. The lien will be executed 30 days from the certified notice date. Just like property taxes you can make your payments the same ways. We also suggest to call to get an updated interest amount so your payment will be in full.

Planning a wedding this year? In order to get married you will need to get a marriage license before the big day! You can go to any town or city hall in the state as long as you get married in New Hampshire. The license is good for 90 days and the cost is \$50. Both individuals will need to be present and we ask that you arrive before 3:30. If either person was married previously we need the certified copy of how the marriage ended, i.e. divorce certificate or death certificate. You may print the worksheet off of the town's website, under the Town Clerk/Tax Collector section.

Last call on the dog licenses! Dogs were to be licensed by April 30th, we do offer the month of May as a grace period to complete the licenses before the \$25 civil forfeiture will be added to the license fees. You may provide us with your email address to add it to your profile to receive the e-reminder. We have sent out two sets of email reminders to our residents to get those pups taken care of on time. Effective June 1st there will be an extra dollar fee per month the dogs are late to be renewed in addition to the fees.

- Preparing daily financial reports and deposits
- Working closely and professionally with the public
- Use of standard office equipment
- Excellent organizational skills and detail oriented
- Ability to work confidently and independently
- Ability to follow oral and written instructions

Applicant must be a resident of the Town of Belmont, NH. A High School Diploma or equivalent is the minimum qualification; however, an ideal candidate would have a familiarity with MAAP, NHVRIN, Election Net, BSMI Clerk, Tax Collect, and a background in accounting. The Town of Belmont has a great benefits package. The position works 40 hours per week. Salary range is \$38,327.60 to \$55,836.07 depending on experience and qualifications. Noise Ordinance



With the warmer weather upon us and more people doing Spring clean-ups, we want to remind residents and businesses in town of the noise ordinance. Between 10:00 p.m. and 7:00 a.m. Monday through Saturday and 10:00 p.m. on Saturday and 10:00 a.m. on Sunday it shall be unlawful to:

1. Operate or use construction vehicles to include but not be limited to bulldozers, graders, dump trucks, backhoes, earth moving equipment, front end loaders and log skidders.
2. Operate or use tools or construction equipment to include but not be limited to cement mixers, hammers, staple or nail guns, power tools: i.e., saws, drills, grinders, sanders; chain saws, lawn mowers, electric hedge trimmers, lawn edger's, and jack hammers.
3. Operate, play, or use any radio, television, phonograph, drum, musical instrument, sound amplifier, or similar device at such a volume that it is clearly audible at the property line of the property on which the device is being operated.
4. Fireworks or cannons.

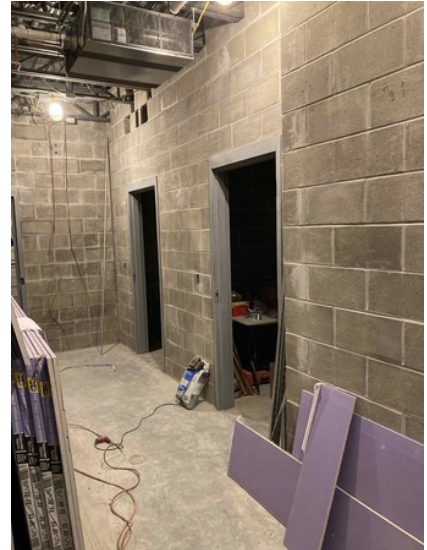

MAILBOX REQUIREMENTS

USPS & TOWN OF BELMONT

HELPFUL GUIDELINES TO FOLLOW WHEN INSTALLING YOUR MAILBOX

- USPS approved metal mailbox required
- Front of mailbox must be 2' from edge of pavement
- Position your mailbox at a min height of 46" from the road surface to the bottom of the mailbox support
- House or Apt. # visible on the front and sides of mailbox
- Minimum 4" x 4" wooden support post
- Supporting post shall be installed 2' below grade and a min 4' from the edge of the pavement

What are the best roofing materials?

When choosing your roofing materials, please consider the following:

- How heavy is this material?
- Will it require special framing to support the added weight?

Choices for Roofing Materials:

- 1) Asphalt Shingles
- 2) Clay/Concrete Tiles
- 3) Metal Roofing
- 4) Slate
- 5) Wood Shingles
- 6) Synthetic Roofing Products



Typically in this part of the region, asphalt shingles and metal roofing are the most popular and least expensive.

Be sure to get multiple quotes, as there are many roofing contractors available. Roofing and building contractors are not required to be licensed by the State of New Hampshire. Check your contract to be certain the contractor is fully insured. Make sure that you are comfortable with the person/company you contract with. Consider asking for references.

Check your contractor's payment policy. Some contractors require one-half upfront, and one-half when completed. Be cautious about paying more than half upfront.

No permit is required for roofing as long as no structural changes are needed. Please note that you can have no more than two layers of asphalt shingles on your roof.

Tick Bite Facts

Avoiding Tick Bites

- Stay on trails outdoors; avoid areas of overgrown brush and tall grasses.
- Wear light-colored clothing so ticks can be easily seen.
- Wear long pants, a long-sleeved shirt, closed toe shoes with socks, and a hat. Tuck your pants into your socks and your shirt into your pants.
- Check yourself, your children, and your pets often for ticks, shower after returning indoors.
- Use insect repellent containing DEET or permethrin (always follow directions).
- After returning indoors, run clothes in the dryer on high heat to kill any ticks that may be on the clothing.



Tick-borne diseases are transmitted to people and animals when they are bitten by an infected tick. The longer an attached tick is allowed to feed, the greater the chance the tick will transmit the organisms that cause tick-borne diseases. Therefore, it is important to take steps to avoid being bitten by ticks and to remove any attached ticks promptly. This fact sheet contains some tips on how to avoid being bitten by ticks, how to do a tick check, and how to properly remove an attached tick.

How to Do a Tick Check

Black-legged ticks are very small, and a tick might look like a freckle or speck of dirt on a person's skin. Ticks often like to bite in warm, dark, secluded areas of the body. It is important to check your clothing for ticks while you are outside, and do a whole body tick check at least once a day. Pay close attention to: hairline and scalp, in and around ears, underarms, elbows, backs of the knees, between fingers and toes, belly button, groin area, and areas where clothing presses against your skin (for example: waistbands, collars, cuffs, watchbands). Don't forget to check your pets as well! Remove any attached ticks promptly.

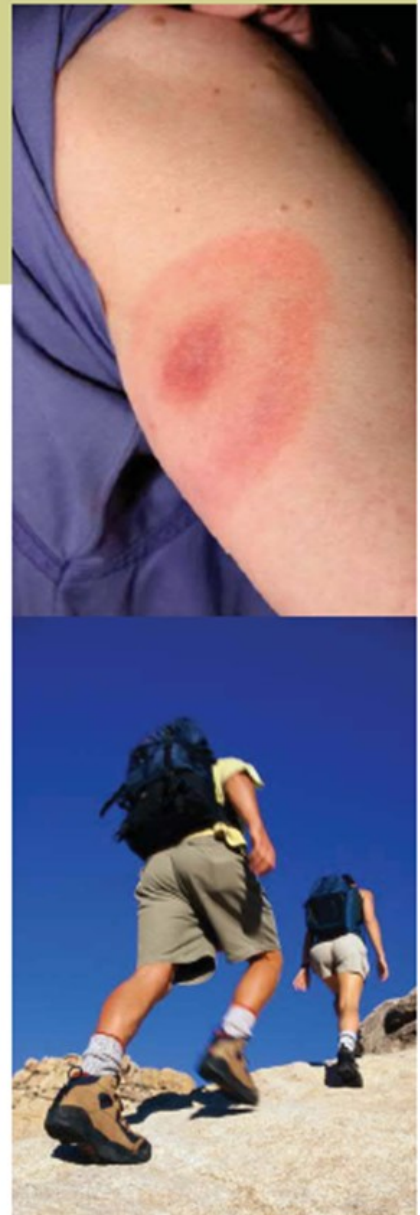

Removing an Attached Tick

- **DO** remove the tick promptly. The sooner you remove it, the less chance of infection.
- **DO** use tweezers to grasp the tick's mouthparts at the surface of the skin.
- **DO** gently pull the tick straight out with a steady motion.
- **DO** wipe the bite area with an antiseptic, or wash with soap and water.
- **DO NOT** remove an attached tick using any of the methods listed below. These may actually increase your chances of becoming infected with a tick borne disease:
 - **DO NOT** squeeze the tick.
 - **DO NOT** rub petroleum jelly on the tick.
 - **DO NOT** use a hot match or cigarette.
 - **DO NOT** pour kerosene or nail polish on the tick.

Is it a tick bite?

- Spider bite: Several fluid-filled bumps appear at the site of the bite.
- Tick bite: The bite may be hard, itchy, and may be reddish and form into lumps. In many people infected with Lyme disease, a red, circular, spreading rash develops at the site of the tick bite. This is often known as a "bulls eye rash" because some clearing often develops in the center of the circular rash, resembling a bulls eye.
- A rash is not a symptom of all tick-borne diseases, and not all people infected with Lyme disease develop rashes. It is important to speak to your physician or primary care provider if you have any concerns following a tick bite or if you experience any symptoms of disease.

A WORD FROM NH FISH & GAME ABOUT BOATING

Despite the recent weather, boating season is right around the corner. NH Fish & Game provides the following boating tips:

1. Don't Overload -- Observe passenger and weight limits.
2. Wear Life Jackets or Vests -- State law requires one wearable life preserver for each person in a boat. All children age 12 or under must wear an approved vest or jacket.
3. Know the Water -- Always carry a chart (map).
4. In an Accident -- Personal safety comes first; report all injuries and damage.
5. Water and Alcohol Don't Mix -- Boating while intoxicated is against the law.
6. Use Your Lights -- All boats operating after sunset until sunrise must display visible lights.
7. Hunting is Prohibited while under power from a motor, as is carrying a loaded firearm (unless you possess a NH pistol permit).
8. Dumping and Littering are Illegal, and punishable as a misdemeanor (up to a year in jail and/or a \$2,000 fine).
9. Don't Harass Wildlife -- Killing or deliberately harassing water birds through the operation of a boat is "Taking" wildlife (fines of \$1,000 or more, and loss of fishing license).
10. Take a Boating Safety Course -- Contact the NH Marine Patrol Bureau at (888) 254-2125 or (603) 267-7256.

Dear Belmont Community Friends,

In 2019 Belmont celebrated its 150th year anniversary. The Heritage Commission began video interviews to document its history through stories of its townspeople. The first set of interviews of former Fire Chief Akerstrom, Everett Weeks, the LeRoux Sisters and Alyce Jewell of Main Street were highlighted in an article in both the *Laconia Daily Sun* and the *Winnisquam Echo*. The more people we interviewed the more names that were given to us to speak to next! In 2020 we continued our quest and we were stopped dead in our tracks due to Covid-19. The Heritage Commission decided to go to “Plan B” and send out questionnaires to help gather information. We are now posting the questionnaire here in our May newsletter. The finished video and information gathered through the questionnaires will eventually be available through the Belmont Library. The Heritage Commission is also hoping to get back into the schools to share Belmont’s history using the information gathered as well.

Please take the time to help our cause by sending in your completed questionnaire by the end of May. Researching and documenting Belmont’s historical facts based on accurate stories from families who lived in Belmont many years ago can only be done with your help.

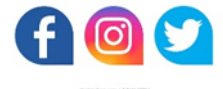

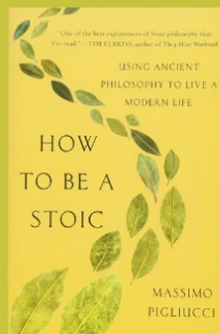
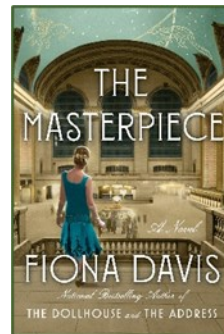
