#### 2022 Tax Rate

The 2022 Tax Rate has been set for the Town of Belmont and bills were mailed on Monday, November 14<sup>th</sup>, with a due date of December 16 2022. This year's rate decreased by \$7.56 primarily due to the increase in overall valuation of the Town.

The Town has consistently tried to maintain stability in its portion of the Tax Rate by balancing the need for services and the town's overall level of property assessment. Since 2007 we have seen a low of \$6.18 to a high in 2016 of \$9.55. This year's municipal rate is \$6.33 which is \$2.21 lower than the 2021 rate.

# The Move to Automated Trash Collection

Belmont was faced with moving to automated trash and recycling collection when Casella announced that was the way the company was moving, and the transition would happen when our contract with



them was up in 2023. As far as the transition to automation, we have been told by Casella that the waste industry as a whole is moving towards automation for several reasons. First, it reduces the necessary labor by a minimum of 50% as they are able to eliminate at least one laborer on each truck as automated trucks only require a driver. In the current labor market, it is extremely difficult to find people who want to work on the back of a trash truck when it's below zero, raining or extremely hot. There just are not many people willing to do that type of work anymore.

The second reason is due to injuries that laborers sustain working at the back of trash trucks. It's the 5<sup>th</sup> most dangerous job in the United States. Just in Belmont alone Casella tells us they average 10+ OSHA recordable injuries to laborers annually.

The third reason is the overall cost for automated vs manual collection which is based on the first two factors. The labor market and injuries have significantly increased the cost of manual collection to the point that the transition to automated collection is the most cost-effective collection program for municipalities.

And lastly, having carts curbside has a much better aesthetic than having piles of garbage bags on the side of the road, that often get opened by animals and trash scattered all around. We know that this new way of collecting trash will be a change for many, and many won't be phased by the process. When carts are delivered, each cart will have information on recycling and cart placement as well as the new schedule for recycling. Requiring residents to recycle will cut costs to the taxpayer as the cost to recycle is less than the cost of trash collection.

#### **Bulky Waste Disposal**



Please note that Casella will continue this program even after automated collection is in place. On the 1st Wednesday of each month, Casella Waste will collect your bulky items curbside. Please note this is for Town of Belmont

Residential Customers ONLY; service is not available to commercial property owners. Piles of debris, trash, yard waste or a single item too large for one person to collect WILL NOT BE ACCEPTED. A request for pickup must be made in advance by calling Town Hall at 267-8300, Extension 118 or 124 only. You will be asked to list the items you want picked up, you will be advised what the cost is, and you will need to drop off a check made payable to the Town of Belmont prior to the collection day. ### TAX ABATEMENT INFORMATION

<u>Abatement applications</u> are available at Town Hall or on the Town's website.

When there is an error in the physical description of your property, or if you feel the assessment is not proportional with other properties, you may file an abatement application with the Town per RSA 76:16.

It is the property owner's responsibility to check their property record card for accuracy. Property record cards are available online at: <a href="https://next.axisgis.com/BelmontNH/">https://next.axisgis.com/BelmontNH/</a> or you may visit Town Hall to review your card.



Please note that assessments for tax purposes are based on the status of your property on April 1st of the tax year.

The current tax bill must still be paid, but if an abatement is granted, it will include a refund with interest.

Your application must include supporting documentation to prove the error description or the disproportionality. Such documents may include, but are not limited to, photographs, comparable sales, independent appraisal.

The **abatement filing deadline is March 1st** following the notice of tax (fall bill issued in October or November). The Town has until July 1st to grant or deny the application. If you disagree with the determination, you may appeal to the State of NH BTLA or Superior Court no earlier than receiving the Town's decision on the abatement, and no later than September 1st.

# Belmont Rolls out New Automated Trash and Recycling Program with Carts

**Belmont, NH (November 28, 2022)** – The Town of Belmont will begin rolling out new garbage and recycling carts for residents next week as it officially launches its automated collection service on January 2, 2023. New carts will be delivered to each residence by the cart company during the week of December 6-10, 2022. If you have a seasonal home and need to request a delayed cart delivery, please call (603) 267-8300 ext. 118.

With this new recycling program, residents will be able to place all recyclable items directly into a new, larger recycling container. The 96-gallon carts will begin arriving at residents' homes in December. The carts will replace the smaller bins currently used for residential recycling and come with wheels for easy maneuvering and attached lids to keep recyclables dry and secure. If you require a smaller cart due to physical limitations, please contact Town Hall as soon as possible.

Casella will collect and dispose of any old unwanted containers and bins the week of December 26-30, 2022. Please write "Take with Trash" on the containers.

The new recycling program is expected to increase the amount of recycling collected in the Town of Belmont. This translates to a cost savings for Belmont taxpayers because it is less expensive to process recycling than garbage. Recycling is also best for our environment.

"The Recycling Partnership is excited to work with Belmont on their new recycling collection program," says Mari Long, Community Program Manager at The Partnership. "We are grateful to GlobalGiving, in partnership with L'Oréal, for their support on this recycling improvement that will increase the amount of recyclables residents of Belmont are able to recycle and get it back into the circular economy to provide much-needed supply for local producers."

The Town applied for and received a grant from The Recycling Partnership, a nonprofit organization that works with city governments nationwide to transform their recycling programs. The Town of Belmont was selected to receive grant support because of its dedication to advancing recycling in the community. The grant from The Recycling Partnership, Global-Giving, made in partnership with L'Oréal, will provide 2,500 new carts and includes funding for education and outreach about the new collection process.

The Town of Belmont asks that residents continue to do their part by placing only loose recyclable materials in their carts, including glass bottles and jars, aluminum and steel cans, food and beverage cartons, paper products (including newspapers and flattened cardboard), and empty plastic bottles and containers. To help limit contamination, give food and drink containers a quick rinse and then place them directly into the recycling cart—no sorting needed.

Some items that cannot be recycled include plastic bags, paper towels, disposable/waxy coated paper products, ceramics or baking glass, electrical equipment, batteries, and clothing. These items often get mixed into recycling carts because of "wishcycling," or the hope that they can be recycled. While well-intentioned, non-recyclable items cause serious issues.

Residents can use their new carts beginning January 2<sup>nd</sup> for trash and January 9<sup>th</sup> for recycling, which will be serviced every other week. A schedule is available on the Town's Solid Waste page at belmontnh.gov and casella.com/belmont-nh or you can pick one up at Town Hall. All education materials will be fixed to the carts when delivered.

# CARTS will be delivered December 6th through December 10th.

Each residence will receive one trash and one recycling cart.

Instruction and Information Packets will be attached to each delivery.


# **Curbside Container Placement Guide**

HELP US TO PROVIDE YOU WITH THE BEST POSSIBLE SERVICE



This guide illustrates the proper and improper placement of your curbside containers and offers tips to help with the curbside collection of materials.

#### CARDBOARD HANDLING




Please breakdown all cardboard so it fits into the cart with the lid closed. Cut oversized material into  $2' \times 2'$  squares.



#### CONTAINER DO'S

- Keep containers on a hard, level surface clear of snow and other landscaping debris and no more than 6' from edge of curb.
- Please allow containers a 3' perimeter of clearance from obstructions such as parked cars, trees, mailboxes and utility poles.
   There must also be a 15' over head clearance from any low hanging tree branches or power lines, etc.
- If you have more than one cart placed at the curb, please set them side by side as indicated in the illustration with at least 3' of clearance between the containers. Do not block sidewalk.



#### CONTAINER DON'TS



Containers must remain upright for pickup



Keep all materials inside the container



Do not place containers back to back



Keep container clear of all obstructions

# TIPS FOR AVOIDING SCAM ATTEMPTS DURING THE HOLIDAY SEASON

The Holidays are notorious for being one of the biggest times of year for fraudsters, phishing, and scam attempts. These criminals are typically overseas and make a full-time living out of committing fraud and theft. I hope this information, tips and tricks helps you and your families

avoid fraud, scam, and phishing this Holiday season. Online shopping, use of email, and other electronic usage can create a perfect storm for cybersecurity threats.

Tips for securing your electronic data to prevent phishing/spyware that can be downloaded into your computer, phone, or other electronic device:


- Don't reuse the same password for everything
- Use multi-factor authentication, whenever possible
- Don't share login information, especially through electronic communication, with others
- When paying for something online, ensure the payment portal is secure
- Delete and clear payment information from any online website, including, but not limited to Amazon
- Review your bank accounts and credit card accounts daily; or at least weekly
- Ensure your cybersecurity software is up to date, active, and scanning your computer regularly
- Spyware allows a criminal to watch your keystrokes, write down your passwords, determine your style of communication.

Many of these types of criminals cultivate a lengthy relationship with you; and then attempt to scam you once they have access to your secure information

- Avoid sending "moneypak cards" and gift cards to someone who is pressuring you to do so
- Call your bank or credit card company directly if anything seems suspicious with your account
- Never mail out cash
- Be cautious
- If you are a senior citizen, be extra cautious as you are a target audience for fraudsters and scammers
- Be cautious with electronic payment websites and apps on your phone and monitor them daily or at least weekly such as, but not limited to: Paypal, Zelle, Venmo, etc.
- Use a secure internet browser when online shopping or accessing your financial accounts
- Setup text or email alerts with your financial institutions to alert you of any suspicious activity







#### **Finance Corner**



Email and electronic communication has skyrocketed in the last decade. Be cognizant of the types of emails you are sending and receiving. Many documents are not considered "legally binding original copies" if they are emailed. Notarized documents are not legal if emailed. An electronic signature is not the same as a wet ink signature. Be cautious of anyone trying to divert your mailed check payments to a new remittance address. Tips for preventing scams/phishing/fraud through email:

When receiving an email requesting money, receiving an invoice, or anything that has to do with a monetary transaction — exercise caution. Hover over the sender's email address/name to ensure the sender's email address is one that you are familiar with

- When in doubt, pickup the phone and call the person/company that is emailing you
- If it smells fishy, it's likely a phishing scam attempt
- Don't send out personal secure information or scan it and email it as an attachment
- Use encryption whenever possible in an email that includes secure information such as your license, your bank account numbers, your credit card numbers, your social security number, etc.
- If you receive a request from a company that you're not familiar with, search that company online to see if they are a valid company

Be cognizant that robocalls are very frequent this time of year. If you are suspicious of a phone call; hang up and call the number or person you



think is calling back. If you receive a phone call from your bank or credit card's "fraud detection department" and it seems suspicious; hang up and call back a number that you know is linked with your accounts and ask if they have been trying to reach you. If someone calls and states that your relative is in prison, hang up and call your family to confirm/deny this. Never give out your personal information over the phone which would allow someone to have everything needed to commit fraud against you or steal your money. Be cognizant that identity theft is also a very real thing. Avoid giving "secure codes" received through text messages received when you're on the phone with a "representative" who has called you. Oftentimes this can be an attempt to transfer money out of your account to a fraudster's account. A company or person that you pay will not likely call and ask you to verify who you are. Do not give out personal or financial information over the phone.

Be cautious with ACH payments. One of the biggest trends in the "black market" right now is cryptocurrency. Once your money has been taken from you through an act of fraud, and it's transferred to cryptocurrency, it is very difficult to recover. When in doubt, call your financial institutions to alert them, your local law enforcement office, your insurance company, your IT network manager, etc. to alert them you may be the victim of a scam attempt.

Our fourth issue water/sewer bills will also be hitting mailboxes this month. The fourth issue covers the months from September through November and will be due in January. The above-mentioned payment options apply to the utility bills as well.

There shall be no overnight parking of vehicles along any roadway between November 15th and April 30th of any year, inclusive.

#### Jessica's Law:

Since 2002, under Jessica's Law, residents are legally required to clear snow and ice off their cars before driving. The law that is cited when someone is given a ticket for not removing snow or ice is:



**265:79-b Negligent Driving.** – Whoever upon any way drives a vehicle negligently or causes a vehicle to be driven negligently, as defined in RSA 626:2, I(d), or in a manner that endangers or is likely to endanger any person or property shall be guilty of a violation and shall be fined not less than \$250 nor more than \$500 for a first offense and not less than \$500 nor more than \$1,000 for a second or subsequent offense.

#### Snow Removal and the Town Maintained Right of Way

The Employees of the Town would never intentionally damage anyone's property while taking part in winter maintenance operations, however there is always potential for damage. To mitigate some of these risks, you may see members of the crew out marking hazards with reflective delineation and whips. In most areas the Town of Belmont maintains a 25 foot Right of Way. The Right of Way is utilized for snow storage as banks grow throughout the winter while still providing drainage for snow melt and sight distance at driveways and intersections. Now is a good time to remove anything from the Town's Right of Way that could be damaged, or cause damage to the department's fleet. Things like planters, Basketball Hoops, and lighting that can either be moved back or removed. Necessary adjustments to mailboxes should be made before the ground freezes. You can find specifications for mailbox installation below that will help keep your mailbox safe this winter:

- USPS approved metal mailbox required
- Front of mailbox must be 2 feet from the edge of pavement
- Position your mailbox at a height of 46 inches from the road surface to the bottom of the mailbox support
- House or Apt. number visible on both sides and front of mailbox
- Minimum 4 x 4 wooden support post
- Supporting post should be installed 2 feet below grade and a minimum of 4 feet from the edge of the pavement

The Andrew Sanborn Farm Property consists of 172 acres± and lies partially over the Stratified Drift Aquifer that underlies Belmont.

#### Permitted Conduct:


Pedestrian uses including cross country skiing and snowshoeing; Horseback riding, only on established trails; Hunting in accordance with NH law; Fishing in accordance with NH law;

Non-motorized bicycles, only on established trails.

Camping is **NOT** permitted; no overnight parking; no kindling of fires. Please be respectful of private property.

Plan Ahead; Play it Safe and most importantly Leave No Trace.

Not only do these animals get to sleep as long as the average teenager, they actually have a weight loss program that works — the winter sleepers lose between 25 and 50 percent of their weight while sleeping.

# **Building Department News**

## from the Building Inspector

The Building Department would like to take this time to remind you of some important permit information:

Property owners are responsible for obtaining all necessary permits for work including electrical, plumbing, mechanical/heat/AC/propane tanks, building, driveways, etc. PRIOR to any work being completed. Some contractors will apply for permits on behalf of property owners. Please ensure that you or your contractor obtain the required permits for any projects you undertake.


- All permits issued require inspections. Depending on your project, some of those inspections may include:
  - ⇒ Site Inspection
  - ⇒ Footing Inspection (when footings are formed and before concrete is poured)
  - ⇒ Foundation Inspection (when walls are formed and before concrete is poured)
  - ⇒ Foundation Drainage (when sealing and drainage is done and before backfilling)
  - ⇒ Structure (when framing, roof, windows and doors are installed)
  - ⇒ Rough-in (when plumbing, electric, and HVAC is done and before insulation)
  - ⇒ Insulation (before drywall/sheetrock is installed)
  - ⇒ Final (check completion, code and zoning compliance)
- Certificate of Occupancy/Use requires:
  - ♦ Driveway inspection
  - ♦ Building Inspection and Sign Offs
  - ♦ Street Number for 911
  - Septic Approval for Operation from NHDES
  - Municipal water/sewer approval from Town of Belmont if necessary
  - ♦ Planning and Zoning Board conditions must be met
  - Fire department permits/inspections of heating source/sprinklers if necessary
  - ♦ Any other agency/permit final approvals as applicable.

Smith's Apple Orchard also received an award for their part in giving to the town community and to its heritage. 

#### LOW INCOME HOUSEHOLD WATER ASSISTANCE PROGRAM (LIHWAP)

The priority is to ensure that households whose services have been disconnected due to non-payment, or are about to be disconnected, are able to have their services restored as quickly as possible.

#### **Program Highlights:**

LIHWAP is a new emergency program designed to assist households with paying for drinking water and/or wastewater services in response to needs precipitated by the COVID-19 pandemic. The program is modeledon LIHEAP but has its own unique characteristics.

Federal funding is available for use through September 30, 2023.

Moderate-Income Program

The Home Performance with ENERGY STAR - Moderate-Income (HPwES-MI) program is open to qualifying customers of Eversource, Liberty Utilities, Until, and NH Electric Cooperative. The HPwES-MI looks to support those NH residents that are over income for Home Energy Assistance (income eligible weatherization program) yet may struggle to cover the customer co-pays in our market rate Home Performance program. HPwES-MI offers higher incentives on weatherization measures and 0% finance options to help cover the customer co-pay.
