Highway Department News

Pavement Marking

Painting Stop Bars, Cross Walks, and Stencil Work, along with both white and yellow lines are always first on the list once spring work is complete. 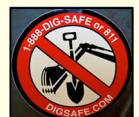
Roadside Mowing

The Town of Belmont engages in annual vegetation control activities for a number of reasons; safety being at the top of the list. Increased visibility and sight distance is a clear benefit to all roadway users including motorists, bicyclists, pedestrians, and even wildlife. Other benefits include keeping drainage systems functioning as designed, restricting small brush from growing into large hazardous trees, and keeping the root systems from growing into the road bed causing subgrade failures. Additionally, it provides crews with a spot to push snow during winter maintenance activities and the increased sunlight provides aid when chlorides are added to melt snow and ice.

Roadside mowing and trimming for sight distance continue for the Public Works crews. The Department has been around addressing sight distance concerns at intersections and sharp corners. Crews will continuously monitor vegetation and mow as needed until later this summer when the entire Town can be completed. As usual, if you see Roadside Mowing signs or other advanced warning devices while traveling around Town, it means the crews are out there. Please slow down, stay alert, and give them room to work.

The Town of Belmont is seeking a self-motivated, detail-oriented, communicative, and respectful individual to fill the position of Land Use Clerk in a fast-paced land use suite. The successful candidate will have a general knowledge of administrative and clerical duties and municipal experience. The Land Use Clerk will play an integral role in the Town of Belmont organization in anticipating and meeting the needs of the community. Duties include: assisting in counter, telephone, and electronic reception duties; intaking and directing inquiries and property compliance complaints; providing general information and answering standard inquiries on property records and documents; providing guidance to the public regarding ordinances, codes, regulations, and processes; receiving, processing, and reviewing incoming applications for initial completeness; assisting in preparing and distributing meeting agendas and packets; assisting in producing mailings; record and distribute meeting minutes as required; preparing permits, reports, correspondence and certificates for review and signatures; maintaining easily accessible paper and electronic files and records in accordance with accepted review standards; and researching, composing, and preparing correspondence and reports as directed. Occasional attendance at evening meetings may be required.

The ideal candidate would have a minimum of a high school diploma and two years of experience in a government, building or land use related position; or any equivalent combination of education and experience that demonstrates possession of the required knowledge, skills, and abilities. Preference will be given to candidates with minute-taking experience.

The Town of Belmont Fire Department is seeking a qualified candidate for an immediate opening for the position of **Full Time Lieutenant/ALS Provider**. This individual will perform responsible shift supervision, firefighting operations, emergency medical care, and other related duties that apply.

MINIMUM QUALIFICATIONS:

- High school diploma or GED (Associates Degree Preferred)
- Certification as a Firefighter II and Nationally Registered AEMT.
- Possession of or ability to readily obtain a valid driver's license issued by the State of New Hampshire for the type of vehicle or equipment operated (CDL-B with tank endorsement).
- Completion of the State of NH Administrative rules, 701.01, 701.02, 702.01, 702.02 or a lateral transfer that meets rule 703.01.
- Possession of Pro Board Fire Officer II certification (or ability to obtain within 1 year)
- Pass a criminal and driving background check

FIREWORKS are often used to mark special events and holidays. The only safe way to view fireworks is to attend a professional show. It is important to know that **fireworks are not safe in the hands of consumers**. Fireworks cause thousands of injuries each year.

A few ideas to get into the patriotic spirit, without fireworks:

1. Use glow sticks, they glow in the dark and are a safe alternative to a sparkler. Fun for all ages.
2. Loud and proud. Noise makers are sure to make a statement. They can be found at local party supply stores or make your own.
3. Outdoor movie night. Set up a screen and projector. Don't forget the bug spray!
4. Red, white and blue silly string...fun for all ages.
5. Make a patriotic craft with the family.
6. Throw a birthday party for the USA, and don't forget the cake.



FACTS

- ! More than 19,500 reported fires are started by fireworks annually.
- ! Burns account for 44% of the 9,100 injuries treated in emergency rooms seen in the month around July 4.
- ! Half of the fireworks injuries seen at emergency rooms were extremities: hand, finger, or leg. One-third were to the eye or other parts of the head.
- ! Children ages 10–14 had the highest rate of fireworks injury, with more than one-third (36%) of the victims of fireworks injuries under age 15.
- ! Sparklers account for roughly one-quarter of emergency room fireworks injuries.

Grilling Safety

There's nothing like outdoor grilling. It's one of the most popular ways to cook food. But, a grill placed too close to anything that can burn is a fire hazard. They can be very hot, causing burn injuries. Follow these simple tips and you will be on the way to safe grilling.

SAFETY TIPS

- » Propane and charcoal BBQ grills should only be used outdoors.
- » The grill should be placed well away from the home, deck railings and out from under eaves and overhanging branches.
- » Keep children and pets at least three feet away from the grill area.
- » Keep your grill clean by removing grease or fat buildup from the grills and in trays below the grill.
- » Never leave your grill unattended.
- » Always make sure your gas grill lid is open before lighting it.

CHARCOAL GRILLS

- » There are several ways to get the charcoal ready to use. Charcoal chimney starters allow you to start the charcoal using newspaper as a fuel.
- » If you use a starter fluid, use only charcoal starter fluid. Never add charcoal fluid or any other flammable liquids to the fire.
- » Keep charcoal fluid out of the reach of children and away from heat sources.
- » There are also electric charcoal starters, which do not use fire. Be sure to use an extension cord for outdoor use.
- » When you are finished grilling, let the coals completely cool before disposing in a metal container.

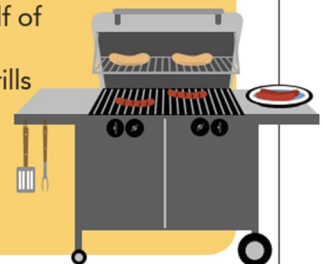
PROPANE Grills

Check the gas tank hose for leaks before using it for the first time each year. Apply a light soap and water solution to the hose. A propane leak will release bubbles. If your grill has a gas leak, by smell or the soapy bubble test, and there is no flame, turn off both the gas tank and the grill. If the leak stops, get the grill serviced by a professional before using it again. If the leak does not stop, call the fire department. **If you smell gas while cooking, immediately get away from the grill and call the fire department.** Do not move the grill.

If the flame goes out, turn the grill and gas off and wait at least **5 minutes** before re-lighting it.

FACTS

- ❗ July is the peak month for grill fires.
- ❗ Roughly half of the injuries involving grills are thermal burns.

FIREWORKS - PERMITS REQUIRED!!

With a permit, Belmont residents are permitted to discharge fireworks displays throughout the year. Permits are issued for one single day at a time, with the exception of the week of the 4th of July, where a permit will be issued for the entire week.

In order to obtain a fireworks permit, the following are required:

- 1) The applicant must be 21 years of age or older.
- 2) The applicant must produce a valid form of ID.
- 3) The applicant must be the property owner, or produce written consent from the property owner to discharge Class "C" fireworks on their property.
- 4) The applicant must notify owners of abutting properties of the date and time of the fireworks display.
- 5) The applicant must produce a sketch of the area in which the fireworks display will be discharged from.
- 6) The applicant must produce a Plan review Submittal Form and Permit Application.
- 7) The applicant must read and understand the Town of Belmont Fireworks Ordinance.

Permits can be applied for at the station between the hours of 7:00am and 7:00pm Monday through Sunday. A one time inspection must be completed by our department in order for the permit to be issued.

It is advised that applications and required documentation be turned into the Belmont Fire Department a minimum of 24 hours before the anticipated discharge of fireworks display to allow members to schedule out the inspections in a timely manner. Be advised that inspections will be scheduled AFTER any and all emergency calls taking place that day.

Vehicle Theft Prevention Month



In 2023, more than 1 million vehicles were stolen in the United States—a 25% increase in vehicle theft totals over the previous few years. Vehicle theft is a multi-billion-dollar crime, costing vehicle owners more than \$8 billion each year. Summers prove to be the worst season for vehicle theft. So, to help drivers keep their vehicles safe, NHTSA is continuing its annual Vehicle Theft Prevention Campaign during July — National Vehicle Theft Prevention Month.

A motor vehicle was stolen every 31 seconds in the United States in 2023.

Use common sense when parking and exiting your vehicle:

- Take your vehicle's key; do not leave it in or on your vehicle.
- Close and lock all windows and doors when you park.
- Park in well-lit areas if possible.
- Never leave valuables in your vehicle, especially if they can be seen from outside the vehicle.

Thieves want vehicle parts and valuable items, too.

Radios and wheel covers aren't the only popular stolen vehicle parts thieves take. They want whatever sells, from the mandated labeled parts to those that aren't. Some of the most popular vehicle parts or valuable items stolen from vehicles include doors, engines, transmissions, air bags, radios, GPS units, cell phones, iPads, laptops, and purses.

There are numerous antitheft systems and devices designed to make vehicles more difficult to steal or easier to trace and recover. Here are how some of them work:

- **Audible and Visible Devices:** These devices, such as a horn alarm, deter theft by bringing attention to an unauthorized attempt to steal or enter a vehicle. Visible devices create a visual threat/warning/deterrence, such as the use of steering-wheel locks, as well as theft-deterrent decals, flashing lights, and window etching.
- **Immobilizing-Type Devices:** These prevent thieves from bypassing a vehicle's ignition system and hot-wiring the vehicle. Some incorporate computer chips in ignition keys or disable the flow of electricity or fuel to the engine.
- **Vehicle Recovery Systems:** These devices use electronic transmission technology that help law enforcement reveal the location of stolen vehicles—and possibly catch the thief in the act.

If you are a victim of vehicle theft, follow these steps:

- Contact police immediately to file a stolen-vehicle report. You will need a copy of the police report and/or a case number to provide to your insurance company. You may also be asked to provide the following information
- License plate number;
- Make, model, and color of your vehicle; and
- Vehicle Identification Number (VIN) and any identifying characteristics.
- Contact your insurance company to file a claim within 24 hours of your vehicle being stolen.
- If you find your vehicle before authorities do, contact the police and your insurance company immediately.

Want to know the cost for a pool permit?

Above ground/seasonal pools are \$25.00 + \$0.15/sf,

In-ground pools are \$35.00 + \$0.15sf

Some things to consider when deciding Above-ground or In-ground.....

- Above-ground pools are semi-permanent, while in-ground pools are permanent.
- Above-ground pools are much less pricey than in-ground pools.
- Above-ground pools take one to three days to install, versus weeks for in-ground pools.
- In-ground pools are generally more time-consuming to maintain.
- In-ground pools are more customizable and last decades longer than above-ground ones.

Conservation Commission

Natural resources largely define Belmont's rural character. Rural character is "*a quality of life and place...characterized by open spaces, historic places, forest and farmlands*" (Belmont Master Plan, November 18, 2002, page 7.1).

BELMONT CONSERVATION PROPERTIES

The Town of Belmont, New Hampshire, in addition to its numerous recreational facilities, has twenty conservation properties that are open to the public. Belmont supports the conservation of open space through the efforts of its Conservation Commission to promote open space preservation and to successfully steward conservation lands under their management. The Commission has been charged with the protection and preservation of land that has been identified as a valuable and irreplaceable resource for drinking water, wildlife habitat and recreation.

JEFF MARDEN TOWN FOREST

The 54.8 acre parcel of land that is now the Jeff Marden Town Forest was obtained by the Town of Belmont in September 1989. The parcel was formally designated as the Belmont Town Forest at the 1994 Town Meeting. The property is located just north of the Village and is loosely defined on three sides by residential lots fronting on Wildlife Boulevard and Laconia Road, and on the fourth side by the Tioga River and the Belmont High School property. The Town Forest lies within the Stratified Drift Aquifer that serves the Belmont Municipal Wells. The property has four areas of frontage on Wildlife Boulevard. The site is generally forested with an impounded shallow pond, wetlands and frontage on the Tioga River. There are several trails, primarily created during an initial attempt to develop the property in the 1970s.

In 2007, the Belmont Conservation Commission petitioned the Board of Selectmen to rename the property the Jeff Marden Town Forest to honor the memory of Jeff Marden. Jeff was a native son, born and raised in Belmont. Growing up nearby, he and his brothers roamed the fields and woods that are now Belmont's Town Forest. In his early 20's, Jeff was paralyzed in a diving accident and confined to a wheelchair. While such an accident might discourage and cause bitterness in many, Jeff instead became an activist and a role model for civic involvement.

He served on the Belmont Planning Board, the Master Plan, Capital Improvements Committee, Shaker Regional School District committees, and the Lakes Region Planning Commission. He chaired the State Architectural Barrier-free Design Committee and was an active member of the State Brain and Spinal Cord Injury Advisory Council. He had a wicked sense of humor, too. He attended many Conservation Commission meetings and was a vocal proponent of balancing development with the preservation of undeveloped lands. A defender of wildlife, he worked at preserving wildlife habitats and corridors in Belmont. And he cared deeply about the Town Forest.

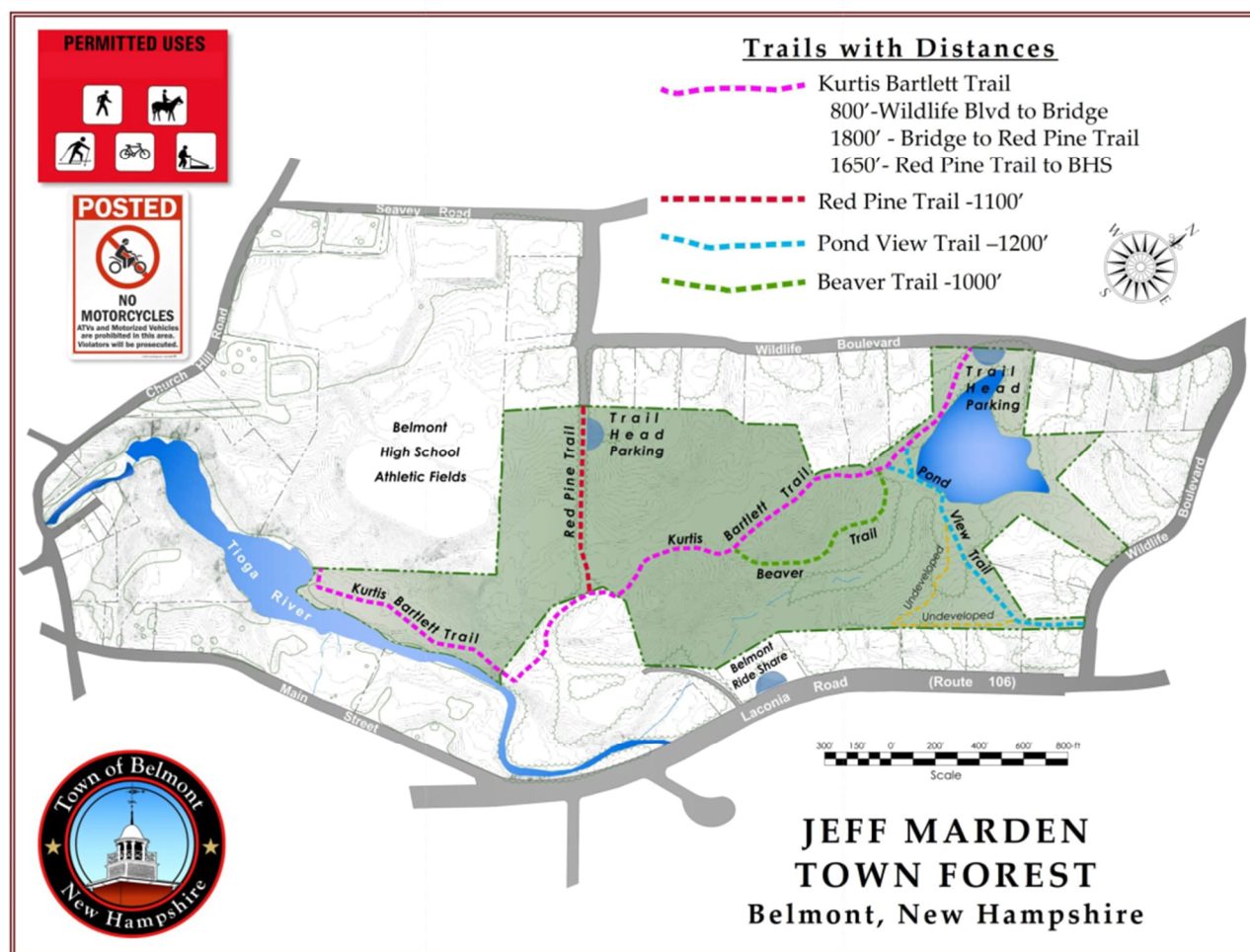
TRAILS

The Jeff Marden Town Forest has 1.4 miles of scenic woodland trails of which two such trails, the Bartlett and Pond View Trails, are universally accessible. Parking is available at the Trail Heads off Wildlife Boulevard. A full size copy of the Town Forest Map (shown below) is displayed in the kiosks at the Jeff Marden Town Forest trail heads.
