2025 Budget Information

Department Heads have worked hard on their budgets for 2025 with our Town Administrator. They are preparing to present their budgets to the Board of Selectmen starting Wednesday, 10/02/2024. Meetings will continue until 10/16/2024 with some hosted in the evenings and some during daytime hours. Please see the schedule and links to agendas on page 2.

Budget Committee meetings will start in November and we are still looking for two registered voters to serve (see page 5).

2024 Tax Rate

The Town and the State are collecting necessary data required to set our annual municipal/Town tax rate. The rate should be set in late October or early November. Tax bills will be generated after the final 2024 rate has been set by the State, and tax bills are typically due in early December.

- Refrain from doing laundry during flushing. Check the color of your water prior to washing laundry.
- Let your water run for a few minutes before using.

You will be asked to list the items you want picked up, you will be advised what the cost is, and you will need to drop off cash or a check made payable to the Town of Belmont prior to the collection day. Town Clerk's Corner



Fall is upon us! It is **officially** spooky season!

October, along with all its beautiful foliage brings the due date for the third issue water/sewer bills. The bills are due October 10, 2024. The third issue bill covers the months of June-August. Payment can be made via mail, in person, dropped in our drop box or on our Town's website, www.belmontnh.gov. We accept cash, check or card but please keep in mind that if you use a card there is an additional 2.79% fee added to the total.

In addition to the third issue bill being due, disconnect notices have been sent out for overdue water/sewer bills. If you have received a notice and have any questions, please reach out to our office at (603) 267-8300 ext 2.

We are busy little bees preparing for the 2024 General Election happening in November. If you require an absentee ballot, please drop off your request and we will mail your ballot to you as soon as they are available. We will have our absentee ballots in the office by the second week of October so if you are planning on being away or unable to vote at the polls on election day, we suggest you give us a call and you can come to Town Hall and request and cast your ballot all in one stop. This prevents the time it takes for the mailing process. If you have any questions, please don't hesitate to reach out.

The 2024 State General Election will take place on Tuesday, November 5, 2024. Polls are located at Belmont High School, 255 Seavey Rd and will be open from 7AM-7PM. The Town Clerk/Tax Collector's office will be closed on Election Day and re-opening at 9:00AM Wednesday, November 6, 2024. All other offices will be open at Town Hall on Election Day. The last day to register to vote at the Clerk's office is Wednesday, October 30, 2024. Otherwise, you will have to register to vote on Election Day at the polls. Be sure to bring your ID and proof of residency.

WHAT'S NEW?

The deadline to request an absentee ballot be mailed to you is noon the day before the election. Previously, voters had until 5 p.m.

Voters must mail a copy of their ID to the secretary of state within seven days of registering to vote if they're doing so for the first time on Election Day and do not show ID at the polls. Voters who don't submit proof of ID by the deadline will have their ballot removed from the final vote tally.

Redistricting in 2022 changed the boundaries of some legislative districts. Confirm your voting district at sos.nh.gov/elections under Voter Information Lookup.

WHAT ELSE YOU NEED TO KNOW**How can I register to vote?**

By mail: You can register by mail if you have an approved reason, such as a disability. If you qualify, call your city or town clerk to request a voter registration form and return it with a copy of your driver's license or other ID.

For details about valid reasons for registering by mail or for documents needed, visit sos.nh.gov/elections and click Register to Vote, then Registering to Vote in New Hampshire. You will need a witness to sign your absentee-voter registration affidavit. Registration deadlines vary by locality. Check with your city or town clerk.

In person: Fill out a registration form at your local clerk's office. You'll need to show ID, such as a driver's license or U.S. passport, proving your name, age, citizenship status and New Hampshire residence.

You can also register at your polling place on Election Day with proof of your identity, age, citizenship status and New Hampshire residence.

filling out a form by hand, call your city or town clerk to request an accessible online absentee registration form.

How do I vote absentee?

You can vote absentee only for approved reasons. Go to sos.nh.gov, select Elections and then Absentee Voting to see the list of approved reasons or to download an absentee ballot application. Complete the form and mail it to your local clerk's office so the request is received by noon on Monday, Nov. 4. You may also drop off your completed form at your local clerk's office.

If you have a disability, you may request an accessible ballot at sos.nh.gov. Click on Elections, then Voting with Disabilities.

Mail your completed ballot to your city or town clerk with proper postage, ensuring enough time for it to arrive by 5 p.m. on Election Day. You can hand-deliver your ballot to your local clerk by 5 p.m. the day before the election.

If you need assistance delivering your ab-

sentee ballot, a delivery agent may bring it to your polling place up until 5 p.m. on Election Day.

A delivery agent can be a family member, nursing home or elder care facility administrator, or another person assisting a voter with a disability. Your delivery agent may be asked to show ID and fill out paperwork to deliver your ballot.

To track your absentee ballot, go to app.sos.nh.gov/viphome and select View My Voter Information.

Am I allowed to vote early in-person?

New Hampshire doesn't offer early in-person voting, but those qualified to vote absentee can do so early at their clerk's office.

Do I need an ID to vote?

Bring an acceptable form of photo ID, such as a state driver's license or U.S. passport, to vote on Election Day. If you are 65 or older, you may use an expired ID. Those without ID can sign an affidavit, have their photo taken and vote, with follow-up verification required.

Is there assistance for people with disabilities?

Yes, polling places have an accessible system and voting booths for voters with disabilities. Accessible absentee voting is an option too, as is curbside voting with the help of an election official. Visit sos.nh.gov, click on Elections, then Voting with Disabilities.

What about military or overseas voters?

Go to sos.nh.gov, click on Elections, then Military & Overseas Voters.

When is Election Day?

Tuesday, Nov. 5. Polling hours vary. For details, visit sos.nh.gov/elections and click on Voter Information Lookup for hours and locations. —Michelle Tuccitto Sullo



Sewer & Septic—NOT FLUSHABLE ITEMS



Sewer & Septic Issues!



Above is an example of an ongoing problem with our local sewer pump stations that service the Town of Belmont. The problem is that non-flushable items are being flushed at an alarming rate!

Non-flushable items are also a problem for property owners with a septic system.

Items that should not be flushed lead to clogs in the Town's sewer pump stations, which interfere with the efficiency of our pumps, and lead to extensive maintenance in order to correct the issue. This requires pulling Town staff from other necessary job duties, and in turn, costs more for all of our taxpayers.

Extensive maintenance was required and more than four bags of grease and non-flushables were removed from this one pump station. It took two employees two and a half days to get this pump back online.

Only human waste and toilet paper are flushable!

Product labels can be misleading:

- **"Flushable" does not mean it is safe for your septic system or sewer. These items can clog your system and be expensive to fix!**
- "Disposable" items are not flushable and should go in the trash.
- Trash – do not flush the following items:
 - Wipes
 - Feminine Hygiene Products
 - Facial tissues
 - Diapers
 - Cigarettes
 - Cotton swabs
 - Dental floss
 - Toys

Highway Department News

Graffiti & Roadside Dumping



The Department continues to deal with an influx of roadside dumping and sign graffiti. Once a sign has been painted like the one pictured above it cannot be cleaned properly. Any solvent the department has attempted to use removes the pigment from the color on the sign along with the graffiti. Replacement sign costs vary, starting around \$45.00 and increase depending on type and size.

Roadside dumping is also a common problem in town. Items left roadside such as the tires pictured above are disposed of through a company that charges the Town per tire. Other items recovered from the Town's ROW are brought directly to the transfer station where the Department is billed for standard scale fees.

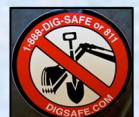
Both of these issues contribute to increasing line item amounts in the Department's budget and only cover the disposal. The actual cost is greater because it takes time from members of your Public Works Team who could be used in places that would better serve the Town of Belmont. If you witness this happening, contact the local PD so efforts can be made to put a stop to this waste of money and resources.

Roadside Mowing

Your Public Works Department continues to work with the limited resources at its disposal. Through the combined efforts of contractors and the Department's trackless, outfitted with its boom mower, we are on target to make at least two passes on every road. This effort is put forth to improve sight distance and reduce vegetation in the ditch lines thorough the Town's maintenance ROW.

Fall Hydrant Flushing !!

In an effort to maintain water quality the Town of Belmont, with help from its partners at Pennichuck Water Works, plan to flush all Town owned fire hydrants between October 7th and October 11th. This process may discolor or affect water pressure, but is not harmful. If discoloration occurs, run cold water until color returns to normal.



Mailbox Specifications

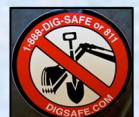
Fall has arrived and now is the time to make necessary changes to mailboxes before the ground freezes. Below are helpful guidelines to follow when installing your mailbox.

- USPS approved metal mailbox required
- Front of mailbox must be 2 feet from the edge of pavement
- Position your mailbox at a height of 46 inches from the road surface to the bottom of the mailbox support
- House or Apt. number visible on both sides and front of mailbox
- Minimum 4 x 4 wooden support post
- Supporting post should be installed 2 feet below grade and a minimum of 4 feet from the edge of the pavement

Halloween is a fun, and spooky, time of year for kids. Make trick-or-treating safe for your little monsters with a few easy safety tips.

HALLOWEEN FIRE SAFETY TIPS

- »» **When choosing a costume**, stay away from long trailing fabric. If your child is wearing a mask, make sure the eye holes are large enough so he or she can see out.
- »» **Provide children** with flashlights to carry for lighting or glow sticks as part of their costume.
- »» Dried flowers, cornstalks and crepe paper catch fire easily. **Keep all decorations** away from open flames and other heat sources like light bulbs and heaters.
- »» **Use a battery-operated** candle or glow-stick in jack-o-lanterns. If you use a real candle, use extreme caution. Make sure children are watched at all times when candles are lit. When lighting candles inside jack-o-lanterns, use long, fireplace-style matches or a utility lighter. Be sure to place lit pumpkins well away from anything that can burn and far enough out of the way of trick-or-treaters, doorsteps, walkways and yards.
- »» **Remember** to keep exits clear of decorations, so nothing blocks escape routes.
- »» **Make sure** all smoke alarms in the home are working.
- »» **Tell children** to stay away from open flames including jack-o-lanterns with candles in them. Be sure they know how to stop, drop and roll if their clothing catches fire. (Have them practice, stopping immediately, dropping to the ground, covering their face with hands, and rolling over and over to put the flames out.)

If your children are going to **Halloween parties** at others' homes, have them look for ways out of the home and plan how they would get out in an emergency.

Did you know?



Decorations are the first thing to ignite in roughly **800** reported home fires each year. More than one-third of these fires were started by a candle.

Heating Safety

There is something about the winter months and curling up with a good book by the fireplace. But did you know that heating equipment is one of the leading causes of home fire deaths? With a few simple safety tips and precautions you can prevent most heating fires from happening.

BE WARM AND SAFE THIS WINTER!

- Keep anything that can burn at least three-feet (one metre) away from heating equipment, like the furnace, fireplace, wood stove, or portable space heater.
- Have a three-foot (one metre) "kid-free zone" around open fires and space heaters.
- Never use your oven to heat your home.
- Have a qualified professional install stationary space heating equipment, water heaters or central heating equipment according to the local codes and manufacturer's instructions.
- Have heating equipment and chimneys cleaned and inspected every year by a qualified professional.
- Remember to turn portable heaters off when leaving the room or going to bed.
- Always use the right kind of fuel, specified by the manufacturer, for fuel burning space heaters.
- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room. Ashes should be cool before putting them in a metal container. Keep the container a safe distance away from your home.
- Test smoke alarms at least once a month.



Heating Equipment Smarts

Install wood burning stoves following manufacturer's instructions or have a professional do the installation. All fuel-burning equipment should be vented to the outside to avoid carbon monoxide (CO) poisoning.

Install and maintain CO alarms to avoid the risk of CO poisoning. If you **smell** gas in your gas heater, do not light the appliance. Leave the home immediately and call your local fire department or gas company.

SHARPS DISPOSAL

The Department has recently received a number of requests for instructions on Sharps disposal. We have provided a two page document from NHDES with this information.

Disposal Tips for Household Generated Sharps

Household generated “sharps” include hypodermic needles and syringes, lancets, infusion sets, and auto-injectors. They are typically used in the home for insulin injections or for administering other medications. Household generated sharps should be disposed of appropriately to help prevent injury and illness to family members and waste handlers, and to reduce pollution to the environment.



Environmental Management of Sharps

NHDES regulates the disposal of household generated sharps (see New Hampshire Solid Waste Rule [Env-Sw 904.01\(b\)\(3\)](#)). Household generated sharps may be disposed of with household trash, if:

1. They are enclosed inside a rigid, puncture-resistant container, such as a plastic bleach or laundry detergent bottle.
2. The screw-top of the container is securely taped closed with heavy-duty tape, such as duct tape.
3. The container is labeled, “**Medical Sharps Container – Not for Recycling.**”
4. The container is disposed of at a facility that is authorized to accept it.



Simply **recapping a syringe is not adequate** to protect against needle sticks. A printable label stating “Medical Sharps Container! Not For Recycling!” is included with this fact sheet. If printed on regular paper, secure the label to the container with clear packing tape.

Although placing household generated sharps in the regular trash is not prohibited when following the above provisions, some solid waste disposal facilities do not accept sharps. Always check with your disposal facility or trash hauler before putting your container in the trash.

Alternative Options for Safe Sharps Disposal

An alternative is to use a **Container Exchange** or **Mail Back Program** that supplies empty containers for clients to fill with sharps and return for safe disposal. There may be a charge for such services. Patients using certain drugs are eligible for safe needle disposal directly from pharmaceutical (i.e., drug) manufacturers.



Other alternatives include using a specially designed needle cutter or **incineration device** purchased from your pharmacy. **Safe needle cutters** clip the needle tip off and allow the user to throw away the rest of the syringe, such as the plastic part, in the trash. When the clipping device is full, wrap it with heavy duty tape and then dispose with your household trash. Make sure the tape covers the sharps insert hole.

REMEMBER...

NEVER throw loose sharps into the trash or toilet!

NEVER leave sharps anywhere they could injure someone!

NEVER store used sharps in glass bottles, soda bottles, milk jugs, aluminum cans, coffee cans or plastic bags!

NEVER put containers with used sharps in a recycling bin!

Building & Code Enforcement—Septic System Maintenance

Notice for Septic Users

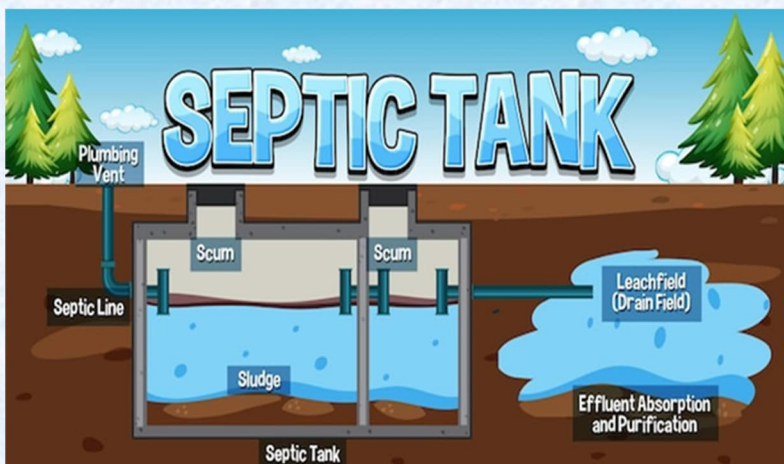
A properly maintained septic system is the key to extending the life of your system. This includes proper maintenance, such as pumping your tank every 2-3 years.

A septic system at its most basic function treats and stores sewage waste from our households. Sewage is conditioned so that it can be dispersed and percolated into the topsoil. This accomplishes the final purification, including destroying disease-producing bacteria.

A septic system in failure is unhealthy, illegal and a nuisance. Replacement costs are high, so proper maintenance can extend the life of your system.

- Inspect your tank every year
- Do not flush grease or toxic materials
- Do not use a garbage disposal unit
- Conserve water
- Don't allow vehicles or livestock on your leach field to protect the integrity of your soil and pipes
- Soggy areas or bad odors can indicate a system failure and should be checked by a professional
- Keep a record of all inspections and maintenance

BELMONT CONSERVATION COMMISSION



Natural resources largely define Belmont's rural character. Rural character is "*a quality of life and place...characterized by open spaces, historic places, forest and farmlands*" (Belmont Master Plan, November 18, 2002, page 7.1).

BELMONT CONSERVATION PROPERTIES

The Town of Belmont, New Hampshire, in addition to its numerous recreational facilities, has twenty conservation properties that are open to the public. Belmont supports the conservation of open space through the efforts of its Conservation Commission to promote open space preservation and to successfully steward conservation lands under their management. The Commission has been charged with the protection and preservation of land that has been identified as a valuable and irreplaceable resource for drinking water, wildlife habitat and recreation.

Andrew Sanborn Farm & Pop's Woods Conservation Areas

The Andrew Sanborn Farm and Pop's Woods Conservation properties are located on the south side of Durrell Mountain Road, at the corner of the Belmont, Gilmanton and Gilford Town Lines, about 2 miles east of the intersection with Route 107 in Belmont, New Hampshire. The Conservation areas consist of two adjacent lots and contains a total of 217.93 acres, including some minor acreage in Gilmanton and Gilford. The Sanborn Farm was purchased by the Town of Belmont in 2008 and Pop's Woods was purchased from Richard and Peggy Meyers in 2010. Both lots contain forested uplands and wetlands and the Sanborn farm also contains a hayfield now used for wildlife habitat. The property abuts protected land in the Town of Gilmanton and is part of a long range project by the Belknap Range Conservation Coalition to protect significant lands in the Belknap Mountain Range.

The properties were purchased with the intent of protecting open space as well as the headwaters of the Tioga River whose adjacent wetlands were identified in 2008 by Stoney Ridge Environmental as the top four wetlands in the Town. The properties are managed under the Multiple Use concept where consideration is given to timber production, forest recreation, wildlife habitat, education and watershed protection.

Wildlife

Interacting with wildlife can be the most memorable part of any forest experience. A variety of wildlife signs have been observed while cruising on the property, including signs of deer, moose, bear, coyote, porcupine, red and gray fox, squirrels, rabbits and mice. Birds of note included wood ducks, geese, ruffed grouse, kingfishers and red tailed hawk. There were no rare or endangered wildlife species observed during the inventory nor are there any listed in the NH Heritage Bureau data check as of September, 2013. The presence of wildlife usually indicates the presence of adequate habitat both on the property as well as on abutting lands for a breeding population. The size of a species' population is usually dependent on the amount of suitable habitat. Animal populations can often be manipulated by varying the amount of habitat, especially if game species are preferred.

Wildlife (cont.)

Providing a variety of habitats will increase the diversity of wildlife. Most wildlife species are opportunists and will take advantage of almost any type of habitat according to their needs. As area habitats are slowly lost to development, it may become more important to replace some of the lost habitats to avoid losing wildlife populations.

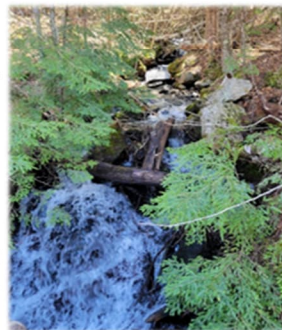
including hiking, mountain-biking, snowshoeing, cross-country skiing, wildlife observation and hunting. These uses are considered relatively environmentally friendly, though some of them can be temporarily disrupted by logging as forest management prescriptions and site conditions will sometimes dictate the time of year when logging will occur. Loop trails are often preferred as opposed to walking back and forth on the same trail or logging road. The woods road system combined with Rogers Road provides several loop opportunities. There is a nice view looking east over the beaver swamp from the bridge on Rogers Road. Several mountains are visible including Durrell Mountain and Grant Hill.

Cultural and Historic Features

There are several cultural and historic features found throughout the properties. They include stone walls, farm ditches and fieldstone farmstead and sawmill foundations along Rogers Road.

Threatened and Endangered Species

There were no threatened or endangered plant or wildlife species observed on the lot during the cruise, nor are there any listed with the NH Heritage Bureau as of September 2013. There were no truly unique habitats or sites that would harbor unique species found during the cruise, though Blanding's and Spotted (*Clemmys guttata*) Turtles may use the brushy, alder areas along the streams and beaver swamps. A few vernal pools were observed on the property and are an important breeding habitat for frogs and salamanders.

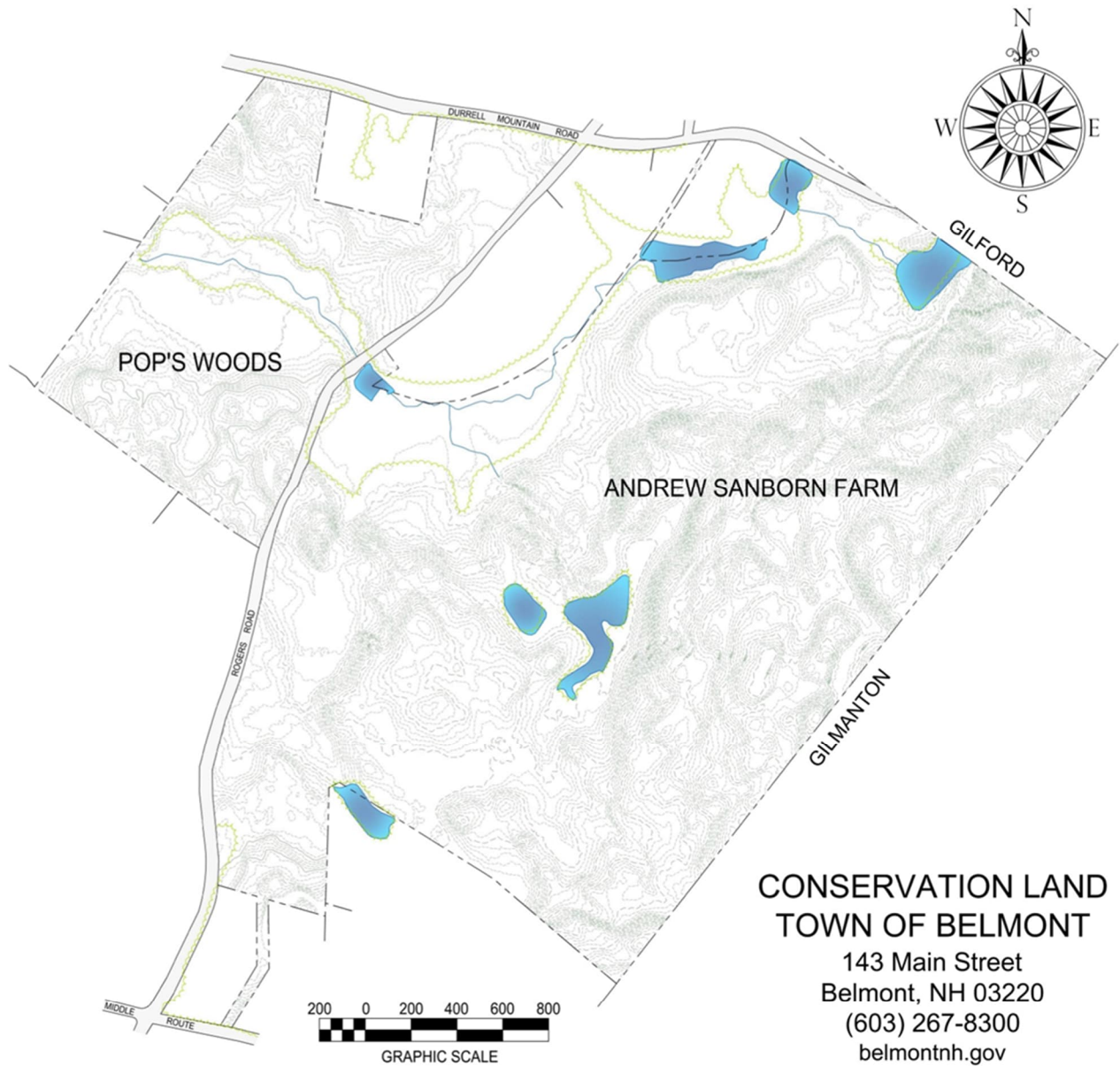
