**Treasurer's report**: The CD current balance is \$8,926.64, checking account current balance is \$5,157.44, for a total of \$17,078.42. Norma opened a second CD which has a current balance of \$4000.00. The total of funds for the Friends is \$18,084.08

Allegra motioned to accept the Treasurer's report, seconded by Connie. All in favor.

### Old Business

Update Eclipse T-shirts – The shirts have arrived. The cost of the shirts was \$1,899.28 for both adult and youth shirts. Hilary sold five at the final summer concert. The sale price of the shirts is \$18.00 for child small and medium, \$20.00 for child large and extra-large, and \$22.00 for all adult sizes. If two or more shirts are purchased at the same time, there will be a \$2.00 discount per shirt. The shirts will be sold online via the Facebook page and the webpage.

Summer Concerts – The profit for the season was \$1,687.12. There were several concerts that were impacted by the summer rain. Norma is to be thanked and commended for her hard work organizing and running the Snack Shack for the summer.

Telescopes – Hilary placed the order for the telescopes quite a while ago. She hadn't heard anything for several weeks after the order was accepted. Kay reached out to the vendor and Hilary received an email explaining that the order was in process and would be sent out for delivery in early October.

Update on PayPal – Estelle will work with Chelsey and explain how the process works at a future meeting.

### New Business

Facebook page – Estelle suggested that those who have a Facebook account like and share the Friends Facebook page and invite their Facebook friends to like the page. This will increase visibility for the activities sponsored by the Friends.
