- Effective 5/1/00 Library closed on Sunday's. Post in newspaper, flyers at the circulation desk, and on doors.
- Real Estate Acquisition:
 - House North of the library parking lot is for sale at \$142,000.00. The asking price is astronomical. Possibility of buying land and renting it out until we are ready to build. Is it worth purchasing? Eminent domain is a possibility, if we are seriously considering this option. First choice of letter to the owners. Can we submit this letter and is it legally binding? Check with attorney to see if we can do it and what is our course of action. Thoughts of extending the existing parking lot onto the lot that is for sale. The Director is to check out prices on the house north of the parking lot and the house on the corner of 79th Street (by the Library). She will also contact the attorney for his advice. Keep in mind earnest money does not get refunded.
