Director's Report: Evans reported on a recent incident that involved the library's surveillance video.

Treasurer's Report: Huff reported that financials are in order. There were no questions.

Discussion Items:

- **A. Remodel next steps**: Evans reported KBA is coming in January to meet with contractors and the Facilities Committee. A budget and phased plan, including specific steps, will then be created. Evans will register the library with a purchasing cooperative recommended by KBA to save on goods and services for the remodel.
- **B.** Holiday dinner: Board members will meet at D'Agostino's Restaurant on Monday, January 7, 2019 at 6:00PM
- **C. CGA Annual Meeting**: Held at Pebblewood on Thursday, January 24, 2019. Evans will make arrangements for board members who wish to attend.
- **D. CD Investments:** Huff reported on the cash and investment schedule. His recommendation is that \$50,000 be invested in a six month CD with Horizon Bank.
- **E. Roof Repair:** Two bids were received for a repair of the flat roof area above the Friends Room. One bid is a temporary fix costing \$725 that can be undertaken immediately. The second bid is a more permanent repair that could be done in the spring for \$2300. Evans was directed to gather quotes for a new roof in the spring.
