

# “Library of Things” Agreement

## **TERMS & CONDITIONS**

The Hampton Falls Free Library, (“HFFL”), as a service to its patrons, circulates items from its Library of Things (“LoT”) collection to HFFL cardholders (“Borrowers”).

The Borrower must have had an HFFL library card in good standing for no less than a 3-month period, and the Borrower’s library account must not have any overdue items.

### **Loan Period**

1. LoT items are loaned out for two weeks.
2. One (1) renewal is allowed at the librarian’s discretion, contingent on any current hold(s) on the item.
3. No more than two (2) LoT items may be borrowed at a time.

### **Hold Limitations**

LoT items may be placed on hold for **3 days**. If the item is not picked up within 3 days, the item will be placed back into circulation.

### **Returning Items**

**All LoT items must be returned to a librarian at the Reference Desk.** Items may not be returned using the library drop boxes.

### **Late Returns**

The Borrower is responsible for lost or damaged items and accessories. Borrowing privileges for the Library of Things may be revoked if an item is not returned in a timely manner.

### **Replacement Costs**

The Borrower is responsible for all LoT items and accessories while the LoT item is checked out on their account. **If any part or accessory of the LoT item is lost or damaged, it is the borrower’s responsibility to pay all replacement costs.**

## **BORROWER’S INDEMNITY STATEMENT**

- I, the Borrower, agree to take full responsibility for the LoT item below and its accessories.
- I, the Borrower, understand that library staff will not provide instruction or training on how to use the equipment.
- Pursuant to New Hampshire RSA 202-A:25, I agree to pay for the replacement of lost or damaged items.
- Use of HFFL LoT item(s) is at the sole risk to the Borrower and the Borrower **AGREES TO INDEMNIFY AND HOLD HARMLESS** the Town of Hampton Falls and/or its officials, officers, agents, employees or affiliates from any loss, liability, damage or costs, that the Borrower may incur resulting from, arising out of, or arising in relation to the undersigned’s use of the borrowed item(s).
- The Borrower represents and warrants that the borrowed LoT item(s) will be used in a safe and prudent manner, in compliance with all applicable instructions and warnings, and in compliance with all applicable law.
  
- **I have read and understand the Library of Things Terms & Conditions, and agree to borrow the item according to the terms and conditions set forth above.**
