Approve Minutes:

Manuel motioned to approve the April 2025 minutes, Gabriela seconded. **Motion passed unanimously.**

PRESIDENT UPDATES: George Mettey

- We need a quorum to have an official vote to remove previous Board Members Roxann Calendar and Bellamy Schmidt from the investment account.
- We also need a vote to change George's title in the account from Treasurer to President.
- Roxann Calendar resigned from the Board (including the Investment Committee) on 10/6/2023
- Bellamy Schmidt resigned from the Board (including the Investment Committee) in June 2024

Brenna motions to remove Roxann Calendar and Bellamy Schmidt from the investment account, and update George Mettey's title from Treasurer to President. Manuel seconds. **Motion passed unanimously.**

- Unfortunately, Tom Gilchrist has resigned for personal reasons
- There's a potential new Board member who has previously expressed interest in joining the Board
- We need a motion to present this person to the Mayor as a potential appointee

Brenna motioned for George to present Meghan Connolly to the Mayor to fulfill the vacant position on the Board, Jackie seconded. **Motion passed unanimously.**

- Last week George and Allie met with the accountant to discuss the 2024 audit and 2024
 990s
- Accountant is submitting the 990s
- No material findings in the audit
- Both due May 15th so George signed off on the 990s and the audit it in the meeting
- Discussed previously but now need to formally vote on sending the investment out for proposals

Jackie motioned for the Finance Committee to go out for bid in June 2025 for investment services. Jacksiel seconded. **Motion passed unanimously.**

- AC compressor will be installed May 21st

- We need to check if there is an actual leak in a window or if we just left it open during the rain
- Jeremy suggests Maria sends an email each year in September/April to the staff saying something like "remember as the seasons change, our heat/AC doesn't change over until May 15th" (or whatever the date is)
- By law we need to provide AC starting June 10th
- Still waiting to hear if the transfer has been approved by City Council for the electrical grounding study

- Partnering with the School Department to host a Family Early Literacy program
- 2nd year we'll be getting interns from Tech Foundry, Omar is interviewing them

 - Maria already discussed this with the custodians and they found the maintenance checklist and they will now follow that checklist
 - May 6th head of department meeting and another department is doing training for DPW custodians and Maria asked for the library ones to be included
