# **Paralibrarian Annual Report**

2022 was a year of rebuilding. Due to the challenges presented by the pandemic over the last few years many aspects of our Section were put on hold. Sadly, this has led to smaller member numbers and lower participation rates. However, this has also presented opportunities to strengthen our section moving forward, such as virtual meeting and training options, as well as instituting marketing campaigns.

This year we have reinstated in-person workshops with the benefit of a virtual option. Offering hybrid classes has allowed us to increase our reach, without negatively impacting library staff schedules, and thereby allows a broader scope of individuals to benefit from our section. The Paralibrarian Section offered three specialized hybrid professional development classes: Introduction to Canva, Successful Programming for Librarians, and Reference Class for Library Staff. In addition to these classes, members of the Board offered our "Preparing Your Paralibrarian Certification Application." All classes were well attended and taught by volunteer library staff. The Paralibrarian Section would like to thank our Education Chair, Hope Garner who worked diligently and tirelessly to help us get back on track with our workshop offerings and provide members these in-person opportunities. We would also like to recognize and thank: Stacey Desrosiers, Barbara Tosiano, Susan Brown, Lee Ann Chase, and Julie Spokane for their time and dedication in helping to meet the continuing education goals of staff from libraries across the state seeking professional development and Paralibrarian Certification.

In our efforts to rebuild our section we instituted a marketing campaign which included a Welcome Packet for new members. This packet outlines vital resources to ensure members a successful certification journey. Additionally, we have instituted a quarterly eNewsletter to relay pertinent information about the Paralibrarian Section and the opportunities it presents.

As of September 12th, we have a total of 63 active members. Although this is less than our target number, our Board is working hard to institute ways to reach current and potential members and streamline the processes involved in attaining certification.

Upon attending the 2013 READS Conference where the Massachusetts Paralibrarians presented about their program, Lee Ann found her calling. Lee Ann helped found the section and immediately joined the Review Board and served as a core member of the committee. In 2019, Lee Ann took over as Chair of the committee until this fall. Lee Ann's patient wisdom and mentoring was a benefit for many of the professionals who achieved their certification.
