- Proposed Bylaw Changes

  - Article VI. Section 1 add READS-to-Go to the list of standing committees

- Article VI. Section 2 add that a Chairperson can serve for 2 years, or until their successor is appointed. Chairpersons can be removed from the Board if the Board sees fit.
- Article IX. Section 1B add that a quorum for membership consists of 10% of READS members attending in-person or virtually.
- Article IX. Section 2A add that the Executive Board can meet in person or virtually
- Article IX. Section 2B defines a quorum for the Executive Board as 50%. Adds the position of Website Coordinator as a voting member of the Board
- Article IX. Section 2C allows the Board to vote through email and will require participation of at least 2/3 of the Executive Board.
