1. OTHER BUSINESS

 Mr. Pollock presented the following item to the members of the Commission:

The Selectmen would like your recommendation on the sale of town property on Winona Heights Drive; R8-1U. The larger lot next to it used to be made up of several lots, then the Conservation Commission had it surveyed, put a conservation easement on it, keeping this particular lot separate. The Selectmen would like to consider the sale of this lot to recoup the lost taxes. They need input from both the Conservation Commission and the Planning Board. Please make a recommendation to the Selectmen, at each of your upcoming meetings.

RSA 80:80 and RSA 41:14a

Under New Hampshire RSA 80:80 and RSA 41:14a, the selectmen should seek the recommendation from the Planning Board and other boards and commissions to determine if there is a future use of a parcel of publicly owned land before they place the parcel on the market for sale.

The Planning Board Responsibility:

The Planning Board reviews the Master plan to determine if the property is of value for municipal purposes i.e. Future Cemetery expansion, affordable housing lot, future conservation area, future road extension or turn around on a dead-end road, wetland protection, aquifer protection or other items

listed in the Master Plan priority list. Once the Planning Board has reviewed its Master Plan it then makes a recommendation back to the Selecmen.

Conservation Commission Responsibility:

The Conservation Commission reviews the Open Space Plan, that is referenced in the Planning Board Master Plan, to determine if the property is of value for conservation purposed. Does it abut other conservation land, is it near a wetland that needs to be protected, is it near an aquifer that should be protected, is it near a stream that should be protected. Once the Conservation Commission reviews its Open Space Plan and makes a determination that the property does or does not meet criteria outlined in the Open Space Plan, the commission then makes a recommendation to the Planning Board and to the Selectmen.

Mr. Schofield recalled that there was a discussion about this parcel by the Commission in the past and felt the recommendation had been to include this parcel with the other conservation land. Mr. Young and Mr. Schofield stated that they would look at the property on October 14th and prepare a summary of their trip for the Planning Board and Selectmen to review.

- Mr. Draper is a member of the Pemigewasset River Local Advisory Committee. They are concerned that an abutter to the Pemi off of Old Bristol Road has cut trees and created a beach without permits and wanted to know if the Conservation Commission can do any anything about it. Mr. Pollock stated that the Commission only has an advisory role and not a regulatory role. The Commission can send out a complaint form to DES explaining what the issue is. Also, we can look at the New Hampton Zoning Ordinance and highlight the Pemi buffer regulations.
- A brief discussion occurred about dumping on the Snake River property.

Mr. Schofield made a motion, seconded by Mr. Young to adjourn meeting at 8:00 PM. Vote was unanimous.
