Temporary Ramp Closure at Exit 23 on I-93

NORTHBOUND OFF-RAMP TO CLOSE FOR SEVERAL HOURS ON JUNE 3rd

The New Hampshire Department of Transportation (NHDOT) announces an upcoming one night off-ramp closure at Exit 23 northbound on I-93 in New Hampton to facilitate ramp paving.

On the evening of <u>Sunday, June 3, 2018</u>, the I-93 Exit 23 northbound off-ramp will be closed to vehicular traffic for paving the existing ramp. <u>This temporary ramp</u> closure will begin at 9:00 pm and continue for several hours.

Motorists seeking access to NH 104 will need to follow detour signs to Exit 24 in Ashland and reverse direction to use the Exit 23 southbound off-ramp. Motorists may also choose to use the Exit 22 northbound off-ramp in Sanbornton and proceed on Route 127 and Route 132 to reach NH 104.

This work is part of a project that consists of pavement rehabilitation, guardrail replacement, slope drainage replacement, pavement rehabilitation at the Canterbury rest area, and widening/ reconfiguration of a portion of the Exit 23 northbound off-ramp.

The Supervisors of the Checklist for the Town of New Hampton will be in Session on Tuesday, June 5, 2018 from 7:00 pm to 7:30 pm at the Town Offices, 6 Pinnacle Hill Road, New Hampton, New Hampshire.

The purpose of this Session is to accept voter registration applications and to make corrections or additions to the Checklist. This is the last day for voters already registered to change or declare a party affiliation. Only un- declared voters may declare a party when they vote on primary election day.

Applicants for registration who possess proof of identity, age, citizen- ship, and domicile should bring that proof when they come to register. Qualified applicants who do not possess proof or who do not bring proof with them may register if they sign an affidavit attesting to their qualifications for identity, age, and citizenship.

More than 30 days before an election, applicants without proof of domicile will be asked to retrieve proof and return to register. Within 30 days of an election and on election day, applicants without proof of domicile with them may register to vote if they sign an affidavit attesting to their domicile and either agreeing to bring or send in proof or attesting that they are not aware of possessing proof of domicile.

Low and Moderate Income Homeowners Property Tax Relief

Taxpayer Assistance - Low and Moderate Income Homeowners Property Tax Relief

The Low & Moderate Income Homeowners Property Tax Relief program was designed to lessen the economic burden of the State Education Property Tax on certain at-risk taxpayers.

An eligible applicant for the Low and Moderate Income Homeowners Property Tax Relief is a person who is:

- Single with adjusted gross income equal to or less than \$20,000; or
- Married or head of NH household with adjusted gross income less than or equal to \$40,000; and
- Owns a homestead subject to the State Education Property Tax; and
- Has resided in that homestead on April 1 of the year for which the claim is made.

Applications for the Low and Moderate Income Homeowners Property Tax Relief are accepted only during the statutory filing period - after May 1, but no later than June 30. The law allows 120 days for processing from the date of receipt of your completed application.
