Public Information Sessions Announced for Northern Pass

The New Hampshire Site Evaluation Committee (SEC) has scheduled a series of five Public Information Sessions.

New Hampton will submit the signed petitions that have been signed by residents, property owners and business owners at the January 14th session in Laconia. If you are holding onto a petition please get it to our office right away. You still have an opportunity to add your name to a petition. Come by and sign a petition at the town offices or print one here, sign it, and drop it off or send it in. Additional Northern Pass information can be found further down on this home page.

The locations, dates and times of these sessions are listed in an order and notice issued by the SEC, as well as a separate procedural order. Under state law, Public Information Sessions must be held in each county in which the proposed facility is to be located within 45 days of a project's application being accepted. Similar to the Public Information Sessions held in September, they give residents another opportunity to participate in the state approval process.

"The purpose of the public information session is to provide the public with information on the proposed Project, to provide an opportunity for comments and questions from the public, and to explain the process the Subcommittee will follow in reviewing the application," states the public notice issued by the SEC today.

Before and during the Public Information Sessions, Northern Pass will also host an Open House for residents who wish to learn more about the project and meet with project representatives one-on-one. Open Houses will begin at 5 p.m. at each of the venues listed
