## **PUBLIC HEARING NOTICE**

### **Proposed Zoning Ordinance Amendments**

**First Hearing:** Tuesday, January 3, 2012–7:00 PM  
Snowdate: Wednesday, January 4, 2012 – 7:00 PM

The New Hampton Planning Board will hold the first Public Hearing on Tuesday, January 3, 2012 to discuss amendments to the New Hampton Zoning Ordinance.

#### **1. PETITION WARRANT ARTICLE TO AMEND Article IV, Section F (6) v (c) District Regulations – Village Precinct - General Provisions; Article V, Section C(3) & Article XIV Definitions – Home Occupation/Professional Office.**

“This petition is to allow outside display of product from a Home Occupation and to amend Article IV Section F (6)v(c) and Article V, Section C (3) to Read: There is no outward appearance of such a occupation with the exception of 100 square feet of product display area and one sign. Also amend Article XIV, the definition of Home Occupation/Professional Office any use conducted within a dwelling and/or within any accessory building which is clearly incidental and secondary to the use of the premises for dwelling purposes and does not adversely affect or undermine the residential character of neighborhood, and in connection with which there is a maximum of 100 square feet of product display area and a permitted sign.”

#### **2. AMEND ARTICLE IV, Section C (3) District Regulations – Mixed Use District– District Property Uses and add the Special Exception Criteria.**

To amend and add - as a Permitted Use by Special Exception, Professional and Business Offices, Banks and Financial Offices, Commercial Service and Repair Facilities and Restaurants with drive through facilities and Special Exception Criteria. This amendment would allow drive through facilities in the Mixed Use District along NH Route 104 by special exception granted by the Zoning Board of Adjustment if the applicant meets the special exception criteria as set out in the ordinance.

If necessary, the second public hearing will be held on Monday, January 16, 2012 at 7:30 p.m. if substantive changes are made at the first public hearing. Snow date: Tuesday, January 17, 2012 at 7:30 p.m.

The full text of the proposed zoning changes are available for public review at the Town Office, Public Works Department, Transfer Station, New Hampton Post Office and the Gordon-Nash Library.
