
We can provide all the details, numbers and history that have made our Renewal Plan absolutely necessary. In December, the Chats will take place during evening hours.

There is currently no vote date set for the bond referendum.

This project has been a standing agenda item for two years now and, as always, the public is welcome to attend all our Board meetings. Every meeting agenda also includes opportunities for members of the public to ask questions and offer comments.

# Library Renewal Project

Though it may not always be visually apparent, our building is in serious trouble. What began two years ago as an exploratory assessment by a team of specialists, has become a growing list of alarming surprises. As engineers have recently concluded, our building is in need of much more than repairs and cosmetics. From its roof to its foundation, from its HVAC to its electrical system, our building is experiencing catastrophic failures and it is living on borrowed time.

It's been 34 years since we asked for a bond referendum for library improvements. And we've done a lot since then, becoming one of the busiest libraries in the county, a vital educational partner, and a meeting place for everyone from toddlers to senior citizens. We love providing the services that we do, and our staff is always ready. But our building can't last much longer. In fact, it's quickly becoming a money pit, requiring thousands of dollars every month for band-aid fixes that don't last and are not sustainable. Taking action now will stop the waste, save money in the long run, and be a sound investment in the future of the Pearl River community.

#### The Proposal

Following 24 months of careful planning, incorporating over 1,000 patron survey results, structural analysis by engineers, and collaboration with Butler Rowland Mays LLP, an architecture firm specializing in libraries, this proposal addresses:

1) Key Safety Concerns

- Upgrading failing infrastructure, including mechanical systems (HVAC), roof, floor, electrical components
- Installing a sprinkler system
- Ensuring ADA compliance

#### 2) Additional Space

- Reconfigure and expand the parking lot by 300% to a total of 51 spaces
- Add full second floor
- Children's Room expansion
- Dedicated teen room
- More meeting, event and study rooms
- Flexible multi-use area
- More family and handicap accessible restrooms

## Why does the current structure have to be torn down?

Our engineers informed us that, since the library was built in 1963, and even since it was last renovated in 1991, building code has significantly changed in New York State. The existing structure would not feasibly allow for the required modifications. Since allowable soil bearing pressure has been reduced, the number of footings that require replacement to support an elevated floor and roof is significantly increased.

For example, additional columns and footings would be needed to support any original walls from the 1963 building, such as the main wall of the Pearl River Room. Given the amount of selective demolition and reinforcing required to salvage existing columns and footings, it was determined to be more economical to remove all existing interior columns and footings, as well as portions of the exterior walls/columns/footings. What does all this mean to us, exactly? We can't build or rebuild on an inadequate foundation.

Red circled/outlined areas

indicate existing columns and footings that are not adequate to support proposed loads.

Blue shaded and circled areas indicate existing footings that are not adequate, and require slab removal to reinforce or replace footings.

**Peach shaded areas** indicate existing additional footings that are not adequate to support loads due to insufficient soil bearing pressure, and expected slab removal to reinforce or replace footings.

<u>Purple dashes</u> indicate walls that need to be completely rebuilt.

Specialists have also determined that our roof and mechanical systems require substantial renovation and replacement. Doing so would necessitate gutting the entire building, leaving not much standing once those two major systems are taken out. For this reason, replacing everything at once would be safer for staff and patrons, faster, and more cost effective.

In addition, because of its size and proximity to Franklin Avenue School and the downtown corridor, our building is on a very restricted site. We can not expand outward. Other possibilities were explored but ruled out as too costly: a new building on a new site, purchasing of property to rehab and renovate to suit. It became apparent that the best option would be expanding upwards, adding a *complete* second floor. Currently, our second floor is a mechanical space and attic.



A full second floor would not only give us more space for collections and programs, it would allow us to have a narrower footprint, and to address the parking issue that has come up repeatedly since the last work on the building was done 34 years ago. Building upward would be more energy and cost efficient.

In the course of exploring the second floor expansion option, we were required to have a detailed analysis of the subsoil conditions and the existing building structure. The analysis revealed that the foundation and the Cherry Brook/water running under the existing building are issues that would need to be addressed in the new plan in order to make the new building structurally sound.

## DUCTWORK

- Ventilation beyond repair & can't be cleaned.
- Decades old soundproofing material is fused to ductwork and disintegrating.



## **FLOORS**

- Carpet often wet/damp
- Uninsulated/unpadded
- Buckling due to humidity as a result of failing AC
- Cracks in cement under-flooring

- Frequently leaks, risking damage to holdings

ROOF

Engineering reports confirm less than 2 years left of life!



- Water pooling, freezing, gathering
- No run off





## **Renewal Project Costs**

#### How much will this cost taxpayers?

The annual household cost would be \$187 a year, or, for many homeowners, 51 cents a day. Taxpayers would be approving a not-to-exceed \$23.5 million project cost.

If approved, the \$187 annual cost to Taxpayers would not be seen until 2023. The length of the term of the bond is 30 years. Interest rates fluctuate daily.

#### Are you getting grants? Are you fundraising?

The Library has earmarked \$322,769 toward the project.

We'll also embark on a targeted fundraising campaign, including seeking donors for naming rights.

We have secured a \$125,000 SAM grant to help fund our present and future building needs.

We will continue to actively pursue each and every grant possible, including NYS Library Construction grants - money that is specifically set aside to fund public Library construction projects.

In fact, since our new director has come aboard we've received more grants than ever before.

For 51 cents a day, you can help support us in creating a library that is capable of providing the community with the full range of services it requires.

But our building can't keep up with the needs of our community or the abilities of our staff. Though the extent of it may not always be visibly apparent, our infrastructure is failing, catastrophically.







Our Library Renewal Plan addresses all of the key issues our bulding is facing. After 24 months of careful planning, we've incorporated more than 1,000 survey results to meet community needs.

#### Key Safety Concerns

Upgrade infrastructure, including mechanical systems: HVAC, roof, floor, electrical components Install a sprinkler system as required by fire code Ensure ADA compliance

#### Additional Space & Parking

Add 51 parking spaces by reducing our footprint, and, at the same time add a second floor with an expanded Children's Room, a dedicated Teen Room and additional flexible spaces.

## Why now?

Our plan is in the proposal stage and it will not go forward without your approval. We've spent two years doing everything we can to get it ready and to get it right. Now we are ready to engage with you in information sessions and one-on-one chats to answer questions. There is no vote date set at this time. The project, as outlined, would not break ground until one year from voter approval, at the earliest.

However, we know that it is no longer financially responsible to continue treading water with a building that needs constant patchwork. The consultants all agree, our building is living on borrowed time and the situation has become unsustainable. Among other things, we will not have air conditioning next summer, and you can't run a toddlers' program or a yoga class for senior citizens without it. Like last summer, we will undoubtedly see roof leaks, electrical failures and intermittent closures. Like last summer, we will see buckling carpet and the hazard tape that goes along with it. The expensive band-aids are not the fix; they are taxpayer dollars going to waste.

Our Renewal Plan not only addresses all the challenges we face regularly now, and all of the underlying issues that became apparent during the assessment process, it also takes into account the changing role the library must fulfill as the educational, vocational and recreational needs of the community evolve with the times.


#### What is the renovated and expanded building proposed to look like?

Until there is voter approval of the project, we will not have any building plans. However, here are two generalized concept drawings of what the building might look like (below), with conceptual renderings of potential floor plans on the following pages.




Built on a sound foundation, the new building would bring the library into compliance with safety and fire codes, and ADA accessibility laws, while also adding a range of family-friendly features the community asked for during Town Hall meetings.

Our proposal provides a parking lot with 51 spaces, a key concern of patrons during our information gathering process.

#### **Tech Library**

The Learning Lab at the Pearl River Public Library has now reimagined and expanded its services to include a brand new high-tech Lending Lab, debuting a variety of exciting tech items available for patrons of all ages to borrow. Most of these materials are available for 14-day checkouts.

Patrons have the option to checkout any of the following items:

- Chromebooks for 3rd Grade to Adults: Great for school or work.
- Edison Robots for all ages: A favorite with Lab patrons, this 2-robot kit makes a great take-home project for parents and kids.
- WeDo 2.0 Robot a great intro for kids K-3: Drag and drop coding and large pieces for young learners. Works with an online app.
- **Sphero Bolt Robot** 4th Grade to Teens: The Sphero Bolt responds to a group of smartphone apps, allowing users to try increasingly challenging coding projects and watch their code in action.
- **Telescope with Travel Backpack** for all ages: The travel kit and smartphone photomount make the telescope great for on-the-go science learning and memory-making.
- **Snap-Circuits Kit** STEM learning for ages 8 and up: An in-depth exploration of electronic components. Learn the basic principles of electronics. Include two project books and a student guide.
- **T-Mobile WiFi Hotspots**: Stay connected on the go! Available for 7-day checkouts.
