Liability Release, Waiver, and Indemnity Agreement for Personal Computer Support Services

Computer or any technology device assistance provided by the Technology Librarian at Pease Public Library is free of charge, done on a first-come, first-served basis, and is only during the available timeslots provided on the “Ask Your Technology Librarian” form. There may be circumstances under which the Technology Librarian may not be available to provide this service computing equipment. The Technology Librarian reserves the right to refuse installation of hardware and/or software if staff believes that such installation may cause damage or create problems once installed.

The Technology Librarian may troubleshoot most technology with patrons, but the role of the Technology Librarian is not Information Technology (I.T.) which includes; computer programming, network administration, computer engineering, Web development, and some technical support. Work performed by the Technology Librarian may void existing equipment warranties, and in the process of working on computer equipment, there is a potential for data loss. If, in the process of working on computer equipment, material is discovered which indicates a possible violation of state or federal law, the Technology Librarian will forward this information to the appropriate department or law enforcement agency.
