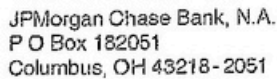

Staffing Issues

1. Staffing Shortage
 - a. January – I will begin to look for another part-time staff member.
2. Staff Day
 - a. January – Staff development day will be held all day February 21. I am working on getting EMS in to do a demonstration and we will have patron relations/de-escalation training as well.
3. Hub
 - a. January – Staffing changes.

Building Issues

1. Facilities Updates
 - a. January – We have found a leak in one of the units in the attic. Ralph and George will be working to fix this in the coming days.
2. Carpet
 - a. November – I have created a RFP and submitted it to the board for approval.
 - b. December – At the board's request, we will look at fixing/replacing the front desk as well. I believe we could get these two projects done either together or separately.
 - c. January – With board approval, I have started sending out the carpet RFPs. I will let the board know as they come in and at what price.
3. Property
 - a. January – No update.
4. Sustainability
 - a. September – A dishwasher would allow us to use ceramic dishes and silverware for programs rather than paper and plastic ware.
 - b. October – I will continue to look into this as time allows.
 - c. November – This month or next month I'll speak with the recommended contractor about what it would take to get this going.
 - d. December – George came out to give a cost estimate for the dish washer in the first floor break room.
 - e. January – We have received the quote for the dish washer. It is my suggestion that we roll that in to a larger building project.

Policies and Procedures

1. Policy Manuals Update & Insurance
 - a. October – We received a grace period to get the necessary changes done to our internal policies.
 - b. December – I have attached additional edits that I would like to see in the manual with my report. I have been in contact with The Judith Bachman Law Firm PLLC. They will be writing the Contractor contract template for the library. This would complete the policy manual and our requirement for the insurance company.

- c. January – The policy manual is with FLEA pending review and the FOIL policy and forms should be finished as of this regular board meeting.
- 2. Patron Conduct Policy
 - a. January – The patron conduct policy is complete and ready to be approved.

Tech Issues

- 1. Website
 - a. October – Each library must find its own website developer.
 - b. November – I have received quotes from several different website developers and I have delivered them to the board for their input.
 - c. December – If the board doesn't have an opinion on who to go with, I would like to start to finalize an agreement with a finalist TBD before the end of the month.
 - d. January – Belsito Communications, Inc. is ready to start on our website. I should be receiving their completion timeline soon.

Friends of the Library and Community Organizations – January 2025

- 1. No Friends meeting since our last board meeting.
- 2. I have been going to Rotary and the Outdoor club meetings regularly to help promote the library.

Programs and Patron Report – January 2024

- 1. Connie will give the program report.
- 2. The Minisink contract patrons will have their library privileges extended until the 21st of January pending board review.

Grants and Funding

- 1. RCLS Grants
 - a. December – Connie applied for a Community Engagement Services Grant. We have received the grant for the learning device and subscription support! We should be receiving it in January.
 - b. January – We have received \$10,000 from the 2024 Senate Bullet Aid grant. This is to be applied for expanded youth programming.
- 2. E-Rate Grants
 - a. January – I had Stacy sit in on a webinar for E-Rate Grants through CIPA compliance. I think it would be a good idea to meet the RCLS representative in February and apply for the grant by becoming CIPA compliant.
