

## **Finance Report**

- P&L Budget vs. Actual Spreadsheet We should be at about 11.5% of the budget and we are at about 10.86%. \$352.93 overage was resolved.
- Paul Densen Trust Fund Update: Current total value is \$112,030.14.

We had 2 CDs - 1 at \$50K and one at \$62K. One matures next week. Chris at Edward Jones offers a new one at .15%. CD rolled over last year matures in April, and is at 1.0%. Consider moving that money into a money market account (1.50% vs CD at 0.15%) It will be about \$50,721. Diana True motions that the CD maturing next week (\$50K plus interest) be moved to a money market account and Carol Busby seconded. Motion passes unanimously. Donations/Grants - \$200 grant from NH Humanities for a program coming up in April. Carol Busby motioned to accept the grant, Carol Fournier seconded. Motion passed unanimously.
