The total amount in the Densen Fund is \$108,626.68

Trustee Stock motioned to move the Densen Fund from TD Bank to Edward Jones with \$100,000 to be invested in a two (2) year CD at 3% interest and the balance to be placed in a money market account associated with the Library's account with Edward Jones. Trustee Fournier seconded and the motion carried unanimously.
