

## Sandown Public Library Trustees Meeting Minutes for August 20, 2020 7:00 p.m. Remote Meeting Sandown Public Library

## Call to Order

#### **Finance Report**

- P&L Budget vs. Actual Spreadsheet. The Library is in good shape financially.
- Paul Densen Trust Fund Update: Treasurer. There is \$112,384.17 in the account as of July 31, 2020. The Library can borrow \$1,235.10 against the balance if necessary.
- The Treasurer has not heard back from Chris Adams regarding the \$589.88 unallocated funds.

**Approval of Minutes** – Carol Busby moved and Carol Fournier seconded approval. Passed unanimously. **Note** that the June Minutes, which have not yet been approved, will be presented at the September meeting.

## **Director's Report – attached separately.**

- Building/Facility The public has responded favorably to the new configuration. A new door counter is being obtained by donation from the Wiggin Library in Stratham. The Basement meeting room has been cleared out. An 82" movie screen has been built for movie nights upstairs in the Library. The director proposed that the library close at 5 on movie nights and then open Sat. from 9 to 3 with a part time page.
- Statistics The number of books taken out per day is increasing. The director is migrating curbside service to window service. The Summer Reading Program is finishing up.
- Budget On track for year to date.
- Staff Lauren Violette has been hired as a replacement for Natasha who leaves 8/31/20.
- Programs Drive-in Movie Nights are going well. The attendance is increasing. Virtual programming continues.
- Books The director will reduce the quarantine on books for 24 hours and wipe them down if requested.

## **Friends of the Library Report**

- Friends met on August 3, 2020. Next meeting September 28, 2020.
- Surplus books from the director's office are currently listed on ebay.

## **Old Business**

- Library is open. The restriction on total occupancy is currently 10 or fewer. Children's room may be reserved on Tuesday & Thursday in one-hour blocks per family unit.
- Signage The Girl Scout who proposed a new sign has not been heard from. The Friends expressed willingness to help fund an electronic sign. After discussion, the Board decided not to proceed with a new sign at this time.
- COVID-19 Update School start dates and formats are still uncertain
- Status of Libraries in NH As of Labor Day, 42% are open.

#### **New Business**

• Circulation policy has been revised to eliminate fines.

Motion to Adjourn by Tina Owens; Seconded by Diana True. Passed unanimously.

The Board then went into closed session by motion of Carol Busby, seconded by Tina Owens.
