STRATEGIC PLAN

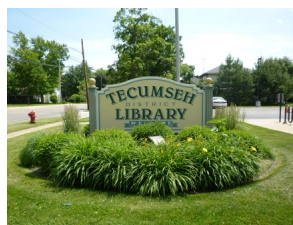

WEBSITE UPGRADE COMING

Our website will be getting an upgrade. It soon will be responsive, which means that it will automatically change its layout and navigational menu depending on the size of the viewing device— full size desktop

display, tablet or smartphone.

The site will also place greater emphasis on accessibility, helping to ensure that those with visual or other impairments can easily access the

information provided.

From an administrative perspective, the site allows library staff to more easily add new pages and content, and more quickly set up and arrange the navigational menu.

CIRCULATION SYSTEM UPGRADE

Our circulation system was recently upgraded to improve customer utilization and improve security. All data is secured and encrypted so users' activities can't be tracked.

The Version 6 platform offers a new user

session structure, meaning patrons can have multiple browser tabs open. The upgraded version enhances the searching experience by offering more ways to filter and customize. Once you find the material, you can easily

place a hold, add it to a saved list or even text the title to your mobile device.

The event is catered by 3 Dudes and Dinner.

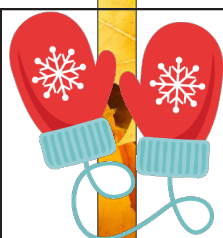
There will be raffle drawings, voting for the best tables and former TDL Director Gayle Hazelbaker will be MC.

LIBRARY BILL OF RIGHTS

The American Library Association affirms that all libraries are forums for information and ideas, and that the following basic principles should guide their services.

- I. Books and other library resources should be provided for the interest, information, and enlightenment of all people of the community the library serves. Materials should not be excluded because of the origin, background, or views of those contributing to their creation.
- II. Libraries should provide materials and information presenting all points of view on current and historical issues. Materials should not be proscribed or removed because of partisan or doctrinal disapproval.
- III. Libraries should challenge censorship in the fulfillment of their responsibility to provide information and enlightenment.
- IV. Libraries should cooperate with all persons and groups concerned with resisting abridgment of free expression and free access to ideas.
- V. A person's right to use a library should not be denied or abridged because of origin, age, background, or views.
- VI. Libraries which make exhibit spaces and meeting rooms available to the public they serve should make such facilities available on an equitable basis, regardless of the beliefs or affiliations of individuals or groups requesting their use.
- VII. All people, regardless of origin, age, background, or views, possess a right to privacy and confidentiality in their library use. Libraries should advocate for, educate about, and protect people's privacy, safe guarding all library use data, including personally identifiable information.
