- ❖ Budget: At 51.9% into FY 2018-2019, Library expenditures are at 50.42%.
- ❖ Fundraisers:  
The Annual Appeal has raised \$2897.50 so far.

On January 11, 2019, Jean will attend the Regional Librarians Meeting at the Butterfield Library in Westminster.

**OLD BUSINESS:**

The Trustees reviewed the articles for the 2019 Town Meeting, including the version of the Library budget article that was written and approved by the Selectboard at its January 2, 2019, regular meeting.

(This version as adopted by the Vernon Selectboard at its January 2, 2019, regular meeting.)

Article #\_\_: To elect a Library Trustee to fill the unexpired term of one year through Town Meeting in March of 2020.

Article #\_\_: To elect a Library Trustee to fill the term of three years through Town Meeting of March of 2022.

Article #\_\_: To elect a Library Trustee to fill the term on three years through Town Meeting of March of 2022.

- ❖ Search for new Trustee: Janis said interviews are being scheduled.
- ❖ Children's area renovation: Jean said she will be working on this.
- ❖ Gift Fund investment policy and strategy and investment ideas: Ellen suggested that we have a policy and strategy for the future for investing Gift Fund monies. Janis and Kristen Dietrich volunteered to work with Ellen to develop draft language.
