- PUBLIC LIBRARY REPORT has been completed. An extension has been granted until January 14, 2022:

- Volunteer and Staff Appreciation was discussed and a placeholder was put on the annual planning calendar for the month of November (instead of December as previously indicated).

It was questioned whether Vernon Free Library could have digital donations in place on their website. This topic will be further explored. Kristin Bratton reminded the group that Five Maples has offered to meet with the trustees to help make appeals more effective.
