Mission Statement

The Wadleigh Library Development Fund is an IRS 501(c)(3) charitable organization chartered to increase and improve the educational, inspirational, cultural and recreational opportunities of present and future residents of the Town of Milford, New Hampshire through the continued growth and development of the resources, services and facilities of the William Y. Wadleigh Memorial Library.

Summary

The Wadleigh Library Development Fund (WLDF) was created in 1985 to provide additional funds during library expansion. \$50,000 was pledged by the Kaley Foundation enabling the fund to qualify for a \$50,000 LSCA Title II library building grant. A couple of years later it accepted donations to install air conditioning.

With its initial task complete the WLDF went dormant until 1992 when it was revived with the intent to create a permanent endowment to fund ancillary library activities. Endowment funds are managed by the New Hampshire Charitable Foundation (NHCF). Depending on market conditions a portion is disbursed to WLDF annually. In addition the Development Fund accepts charitable donations directly and uses them to fund library programs and equipment purchases or transfers excess monies to NHCF for long term growth. For convenience donations may be made online at the library's web site.

The existing fund 2946-1 AGENCY is only able to accept funds deposited by the WLDF. Both funds are endowments paying out a varying annual amount based on market conditions. Funds need to be kept separate to comply with Financial Accounting Standards Board (FASB 136) standards.




Figure 1 Fundraising Bookmark



Notable Events:

- Fund revived by Denise Johnson for purpose of providing "an avenue for the continued development of funds supplementary to those derived through the normal budgetary process."
- Goal was to create an endowment of at least \$50,000 to fund library activities in perpetuity.

Grants:

- \$7,500 for children's books.
- \$30,000 for air conditioning

Notable Events:

• Library was not air conditioned resulting in very high summer temperature. Kaley Foundation donated \$20,000 and Keyes Memorial Trust \$10,000 to install air conditioning.

1986

Grants:

- \$2,500 for children's books.
- \$100,000 for elevator

Notable Events:

- Cogswell Benevolent Trust donated \$10,000 to purchase children's books.
- IRS approved WLDF application as a 501(c)(3) charity. EIN 22-2670704

WLDF was established in December 1985 to qualify for \$50,000 library construction grant at time of library expansion.

Grants: none

Notable Events:

- Voters approved \$950,000 warrant article for library expansion. This was significantly less than
 construction bids. Library Director, Art Bryan submitted a Library Services and Construction Act
 (LSCA) Title II construction grant application for \$50,000 contingent on obtaining matching local
 funds.
- The Kaley Foundation contributed \$10,000, and pledged additional \$10,000 donations in 1986, 1987, 1988, 1989 plus interest.
- Milford Coop Bank provided WLDF a \$50k line of credit to be repaid by the Kaley Foundation. Kaley Foundation paid off loan in only two years.
- WLDF received letter from Shirley Adamovich, New Hampshire State Library. "We are in agreement that these funds in the amount of \$50,000 may be used as the required matching grant for the Library Services and Construction Act Title II construction grant recently awarded to the Wadleigh Board of Library Trustees. "
- WLDF was registered as a charitable entity with the state of NH with five trustees:
