Each piece of 2D art must be framed or finished around the edges and ready to hang with wire or other appropriate method. No saw-tooth hangers. Your name and contact info must be on your artwork.

**Delivery and Pick-up**

Artists will be notified via e-mail if they've been accepted for showing and their scheduled dates for drop-off and pick-up. Artwork not picked up on time will be kept in Administration.
