4.I. Discussion And Possible Action On A Fine-Free Policy

Discussion Of Library Procedures Relating To Public Health Issues Based on discussions with the other members of our library system and a presentation from DPI on their Guidelines for Reopening which are a work in progress, we have started the planning for Phase One Library Service Level Three.
